



# Nigeria to see growth rebound in Q2, Q3 2021 - World Bank

Nigeria is set to see a rebound in growth in the second (Q2) and third quarter (Q3) of 2021, according to the World Bank in a new Nigeria Development Update report seen by Money-Central.

The World Bank report notes that:

"Nigeria's economic temperature (NET) is getting warmer, hinting at a growth rebound for the second and third quarter of 2021."


The NET Index is produced by the World Bank and measures the "temperature" of the Nigerian economy based on a set of 14 high-frequency indicators.

These indicators include headline inflation, oil prices, manufacturing PMI, Treasury Bill rates, currency in circulation, exchange rate indicators (e.g., premium between the parallel vs. NAFEX rates), external reserves, and credit to the private

The color coding is based on the deviations

of each indicator relative to a 5-year average. RED indicates potential stronger growth (the economy is heating up). BLUE indicates the opposite (the economy is cooling).

Quarterly GDP growth in Nigeria has resumed but remains below the levels of 2017-2019, with GDP rising by 0.51 percent in Q1, 2021.

## Edo introduces telemedicine to Health Insurance Scheme

The Scheme is the brainchild of Governor Godwin Obaseki and is geared to service all categories of medical care needs in the state.

## BUA Cement says no further increase in cement prices

BUA Cement, Nigeria's second-largest cement maker, has again assured Nigerians that it won't further increase the price of cement. This is the second time BUA is reassuring its customers in the past two months.

This was confirmed from a statement it shared on its Instagram page on Friday.

The statement from BUA Cement read:

"We have been inundated with requests from our distributors seeking clarifications as to whether BUA also intends to increase the price of its cement. This is in view of a purported 10% price increase by another major

cement manufacturer.

"While we are now aware that the said producer has increased the price of its cement (exfactory) effective Monday, June 14, 2021, we however wish to state that BUA is not a part of this increase and does not seek to increase the price of its cement (ex-factory) in the foreseeable future."

BUA Cement recently released its 2020 Full Year Audited Financial Results with the company declaring a Profit After Tax of N72.3billion representing a 19.4 percent increase over the corresponding period in 2019.

BUA Cement's revenues also grew to N209.4billion from N175.5 billion, as at FY2019.

## Reconstruction work to begin on Papalanto-Ilaro-Sagamu Interchange Road soon – Abiodun

The Ogun State governor, Dapo Abiodun has disclosed that his administration had reached an advanced stage of discussion with the Federal Government for the reconstruction work on the Papalanto-Ilaro-Sagamu Interchange Road.

This is just as he said that the ongoing construction work on the Ilaro-Owode Road was deliberately broken into sections in order to speed up the rehabilitation of the road.

Abiodun made this known over the weekend while speaking at the 11th Synod of the Diocese of Yewa, Anglican Communion, Ilaro.

The Governor at the Synod with the theme, "But, They That Wait Upon The Lord", declared that "there is probably no local government in Ogun

West where construction is currently not going on."

"There is no local governmentin Yewaland that is not constructing roads. Here, in Ilaro, we are doing the Ilaro-Owode Road, that project has been slower than we anticipated and I have since intervened. I have decided to break that project into two and leave part of it with the existing contractor, and bring in a new contractor to speed up the construction of that road.

"Thave started discussions on the commencement of the Papalanto-Ilaro-Sagamu Interchange Road, our discussion is at conclusive stages. So, very soon, you will see mobilization to site for the construction of that road. That road is a very critical one for our East to West connection," he said.

The governor, who also disclosed that his administration would be inaugurating the Imasayi Road in Yewa North Local Government later in the month, also added that roads in Imeko and Ipokia would also be inaugurated in the next three weeks.

Abiodun, however, urged landlords in the state to ensure that they know their tenants well enough, declaring his administration would not hesitate to demolish any property found to harbour kidnappers and other criminals.

He further called on the congregation at the Synod, to continue to see each other as their brother's keeper, adding they should continue to believe in the unity of the country.

"Our administration is determined to rid the state of bandits, kidnappers and other criminals. If we arrest any kidnapper, bandit or any other criminal, not only would we deal with him to the full extent of the law, we would also demolish any house found to be harbouring criminals. So, you must know your tenants.

"I want to admonish us that

these are difficult times for this country, we need to see ourselves as our brothers keepers. You know the Bible says we should love our neighbours like ourselves. This year, there is so much banditry, kidnapping, and the reason why people are calling for secession and break up of this country. That must not happen, it is only someone that does not recall what happened during the Civil Warthat will continue to beat the drums of war, we will not be attributed by any ploy to divide this country, we believe in the oneness and indivisibility of this country because there lies our strength," Abiodun posited.

## Nigeria's annual inflation rate rose by 17.93% in May — NBS

The consumer price index which measures inflation increased by 17.93 per cent (year-on-year) in May 2021.

The National Bureau of Statistics (NBS) disclosed in its Consumer Price Index report for May which was released last week.

This is 0.19 per cent points lower than the rate recorded in April 2021 (18.12 per cent).

Increases were recorded in all COICOP divisions that yielded the Headline index.

On a month-on-month basis, the headline index increased by 1.01 per cent

in May 2021. This is 0.04 percentage points higher than the rate recorded in April 2021 (0.97 per cent).

The percentage change in the average composite CPI for the 12 months period ending May 2021 over the average of the CPI for the previous 12 months period was 15.50 per cent, showing a 0.46 per cent point rise from 15.04 per cent recorded in April 2021.

The urban inflation rate increased by 18.51 per cent (year-on-year) in May 2021 from 18.68 per cent recorded in April 2021, while the rural inflation rate increased by 17.36 per cent in May 2021 from 17.57 per cent in April 2021.

# Ease of doing business: presidential c'tee ranks Gombe number 1

Gombe State has been ranked first among states that have provided attractive environments that promote business growth in Nigeria.

This was contained in a result of the State Ease of Doing Business Survey undertaken by the Presidential Enabling Business Environment Council (PEBEC) as a status report on the current attractiveness of states business climates for small and medium sized enterprises (SMEs).

Gombe is followed by Sokoto, Jigawa and Akwa Íbom States who ranked 2nd, 3rd and 4th respectively.

The subnational survey methodology framework was developed by the PEBEC-NEC Technical Working Group comprising representation from six states embodying the six geopolitical zones, the NEC (National Economic Council) Secretariat, Nigerian Governors Forum, the Nigerian Bureau of Statistics, the Nigerian Investment

Promotion Commission, the Nigerian Export Promotion Council, the Nigerian Summit Group and other private sector representatives.

The PEBEC and NEC are chaired by Vice President Yemi Osinbajo.

The homegrown indicators used in the survey are infrastructure and security, transparency and access to information, regulatory environment and skills and workforce readiness.

Each state was rated on a ten-point scale across the indicators, which provided the basis for calculating the overall performance of the state.

The field survey was conducted by KPMG Professional Services between November 2020 and January, 2021.

The survey captured the reforms baseline enabling each state's ease of doing business council to craft their own reform agenda and implementation roadmap based on empirical data and feedback from a cross section of 998 SMEs across the 36 states and the FCT.

A breakdown of the result showed that in Infrastructure and Security, Gombe scored 5.86 in Electricity, 5.86 in Transportation, Primary Healthcare 7.50 and Security, 7.99, with an average score of 6.80.

In Transparency and Access to Information, the state scored 9.35 in Investment Promotion and 8.69 in State Information Structures, with an average score of 9.02.

In the regulatory environment, it scored 5.75 in paying taxes, 8.21 in Starting a Business, 6.44 in Enforcing Contracts and 7.64 in Land, Property Acquisition and Development. Its average was 7.01.

## El-Rufai sacks 99 political appointees

Governor Nasir El Rufai of Kaduna State says the government has begun to implement its rightsizing policy by disengaging 99 political appointees.

He, however, stated that the state government had yet to disengage any civil servant as only agencies connected to the local government system have disengaged staff.

The governor who briefed reporters on Thursday listed those affected to include the 23 local government councils, State Universal Basic Education Board (SUBEB), and the Primary Health Care Board.

He explained that the disengaged political appointees constituted 30 per cent of the total number of political office holders in the state.

'So far, 99 political appointees have lost their jobs, but we have not commenced rightsizing civil servants," said Governor El-Rufai.

He added, "We want to be fair with regards to civil servants. We had earlier prom-

ised that before we reduce the size of the civil service, we will start with political appointees, and we have done that."

The governor stated that the rightsizing of civil servants would still go on as planned because of dwindling revenues that were accruing to the state government from the federation account.

He added that rightsizing commenced with political appointees because their details were clearly known, making it more straightfor-

ward to disengage them. Governor El-Rufai clarified that civil servants whose veracity of data had raised questions have been given a chance to clear the doubts before any action would be taken.

He disclosed that the government has employed 11,000 more workers in the health sector, Kaduna State University, as well as primary and secondary school teachers across the state.

The governor also faulted the claims that the salaries of political appointees accounted for the bloated personnel cost of the state government.

## I am serving my people even without being Governor – Maikaya

Alhaji Musa Maikaya is a chieftain of the All Progressive Congress APC, in Nasarawa state, he aspired to be the governor of Nasarawa state under the platform of the APC in 2019. In this interview with select Journalists in Toto his home local government, Chief Executive Office CEO, of Maikaya foundation bares his mind on the administration of Gov. AA. Sule. MoneyCentral's Northern Bureau Chief NATHANIEL GBAORON, was there and brought the excerpts...

You Aspired to be the governor of Nasarawa state in 2019 and you lost out to the present governor at the stage of primaries; are you considering contesting come 2023?

Before now I considered the seat of the governor in Nasarawa state, in the last dispensation, as it were I wasn't the chosen candidate and as God will have it, we have Engineer A. A Sule as the governor. For me that aspiration wasn't born out of I needed a position, it was out of I needed to serve. You know there must be one governor which we have now. Therefore the idea of serving my people I think shouldn't be through one singular channel. That's why for me from 2019 till date, there are lots of activities that My foundation, Maikaya development foundation have done. It's a way I think we can provide services to the people or mankind with our limited resources. So talking about governance in the state, to me we have a governor on seat right now so there is still time. At the moment it's not something I'm even thinking of to be honest with you, not

at the moment because we have a governor who is virtually two years on the seat. We all contributed to him being there, I am sure you know other candidates in APC who rally round the candidate to ensure we neip him get victory at the polls. I am sure you notice that he was supported till the last moment because we all collectively agreed to work for the party and to ensure he won and if you notice what came out of Toto Local government, I am sure statistics show that Toto is a true supporter of A.A Sule, so at this point in time we still maintain our support for him, he is half way into the first tenure and as you all

know, he was not in government before but in the private sector. I think he still has the time to get the grasp of what he planned to do for the state. Hopefully we would be able to see something at the end of the first tenure in the state. For anybody or for me as an individual to start thinking of governance of the state while he is just two years in power I think that will be counter productive.

Are you saying your hope of becoming the Governor of Nasarawa state is dashed?

No dashed in what way? dashed when A.A Sule succeeded? dashed within what? Not when he is on

the seat, so there should be a boundary where you describe dash. You are talking about somebody who is halfway into his tenure so nobody should aspire for anything and again today we have APC and we are all in APC, we have an APC governor on seat that we all supported to be on seat and we are okay with him, talking about any other aspiration it is after or when he is completing his mandate we have given him. When that time truly comes up we shall know if there is nothing like dashed aspiration but for now there is nothing like that. Yes we have somebody on seat and we supported him to be on seat and we're still supporting him to perform and make a difference.

Are you saying you're comfortable with the way Governor AA. Sule is running his own administration?

First and foremost, I must say without any form of ambiguity that the governor means well, he just came into government, he wasn't part of the last administration, he would have had his plan like you said, he has his manifesto, until he gets to that seat is on ground. If you don't know what is on ground you probably are assuming from what you see, but the reality is when you are there. I know that there are issues around education recently when he came up, trying to uncover some frauds, am sure he didn't know about that when he came in, not just that, for you to even talk about development in anywhere in the world, you need to talk about security, if you do not have security there is no way you can talk about development in any area and security I believe anybody in Nigeria knows that Sule is one of those governors that have been  $running\,to\,Mr\,President\,to$ seek support on security. He has been calling on the world to seek support, that shows it's a key issue to him and security is not something you can predict or get your data or information as planned, it can come up anywhere, anytime there could be breach anytime and suddenly you have a threat situation around security. For me, if I want to assess him I will start from whether there is an enabling environ-

ment for him to even put those things he plans in place, we all agreed where security is in Nigeria today. Nasarawa state is not left out, Nasarawa state is one of the key state in Nigeria in terms of security, Toto particularly, I will say 18 months ago you won't be able to come here, if anybody tell you to go and mine or pick gold on the street of Toto, people were not coming because of insecurity but we clearly saw his efforts and today people are coming in, people are celebrating sallah. It is one thing even if you are his enemy you will give him credit for this one so if you want to measure him in other things you will have to begin from there, that is the fundamental tning then he can take off from there He has his plans but again what he met on ground was probably not what he thought. As long as security is concerned you don't have anywhere you can isolate a state. If there is insecurity in a neighbouring state it is likely to catch up with your own state, we have had so many breaches around our neighbours and which

## Court convicts 6 Shila boys, attackers of DSS officer

Tears rolled freely from the eyes of 7 dreaded Shila Boys when the Chief Magistrate Court II sitting in Yola, Adamawa state pronounced their conviction to 3 -5 years in prison for various offences.

While some of them were convicted and sentenced with an option of fine, others were not due to the gravity of offences upon which they were

tried and convicted. The convicts were arraigned before Magistrate Japhet Ibrahim Basani, led Magistrate Court on Thursday, on various offences ranging from criminal conspiracy, theft, extortion, criminal force

and several others.

## World Bank Inflation Report a Wake up Call for Authorities

A new report from the World Bank released last week confirmed that high inflation is reducing Nigerian's purchasing power, with rising food prices as the main driver.

In the past year food prices accounted for almost 70% of the total increase in inflation which rose in 2021-21 from an already high level.

Inflation is exacerbating poverty and food security in Nigeria, with the World Bank estimating that falling purchasing power is expected to have pushed about 7 million more Nigerians into poverty.


Nigeria's annual inflation increased by 17.93 per cent (year-on-year) in May 2021, the National Bureau of Statistics (NBS) disclosed in its Consumer Price Index report for May which was released on Tuesday.

This is 0.19 per cent points lower than the rate recorded in April 2021 (18.12 per cent).

Galloping food prices have heaped pressure on households in Africa's largest economy, which is also facing a shrinking labour market and stagnant growth at a time of mounting insecurity.

The rise in inflation especially the food component is a blow to Nigerians already reeling from high unemployment, stagnant wages and a slow growing economy.

Nigeria's economy went into recession - its second since 2016 - in the third quarter of 2020, as the coronavirus pandemic caused oil prices to crash, slashing state revenue.

With prices more than double the bank's inflation target band of 6% to 9% there has to be some concerted efforts to begin

to tame the monster.

Inflation is a decrease in the purchasing power of currency due to a rise in prices across the economy.

When inflation is too high, it is not good for the economy or individuals. Inflation will always reduce the value of money, unless interest rates are higher than inflation. And the higher inflation gets, the less chance there is that savers will see any real return on their money.

In Nigeria today the inflation rate is higher than the risk-free rate and yields on other major assets like fixed deposits in banks, savings bonds and corporate debt.

For the CBN some of the recent statements from its monetary policy committee (MPC) members suggests that they see rising inflation more as a result of the structural deficiencies in the domestic economy.

Adamu, Edward Lametek, a member of the MPC notes that:

"Given that food prices have remained the major driver of the overall domestic price pressure, the role of money can be assumed to be minimal. As such, the correct policy-mix must continue to include a focus on alleviating supply from both production and distribution sides."

For the Federal Government, it is paramount to improve security in most of the food producing basins in the country, which have been hit by deadly farmer-herder conflicts.

The FG should also deal with bottlenecks in regulation, and at the Ports that are adding to the cost of doing business and hence rising prices.

## Analysts recommend Buy ratings on GTBank ahead Holdco structure

The train is leaving the terminal and whoever has not bought a ticket could be left behind and miss out on a fantastic vogue.

Investors will be shooting themselves in the foot and gnashing their teeth if they do not have Guaranty Trust Bank's shares in their portfolio; this is because the Holding Company Structure as proposed by the lender is expected to add impetus to earnings.

To diversify its revenue base and remain competitive

in the light of the current regulatory environment and market dynamics, GTBank has decided to adopt a model that will comprise commercial banking, payment services, and pension fund assets.

Analysts at Chapel Hill Denham said in a latest report to clients that the low Nigerian pension Asset Under Management (AUM) as a relative to the GDP compared to African peers is positive for the Holdco structure.

They added that Nigeria's youthful population and the recent introduction of transfer windows in the pension industry are tailwinds for profitability.

The bank can also leverage on its existing infrastructure and client base to bolster earnings in the payment service and asset management segments, according to analysts.

The recent apathy for equities that depressed the shares of bellwether companies is a blessing in disguise for GT-Bank as its share price trades below fundamentals, making it cheap and attractive.

It has a price to earnings ratio of 4.89 times, and it has a high dividend yield and analysts expect a high payout at the end of 2021.

Analysts at Chapel Hill have reiterated their BUY rating on GTBank and raised their target price (TP) by 8.9 percent to N46.89, implying a total return of 73 percent (FY-21E dividend yield: 11.4%).

GTB trades on a FY-21E P/B of 0.91x and ROAE of 24.5 percent. The share price is down 10.66 percent YTD.

"We see the current market price as an attractive re-entry point. Based on our assumptions, we arrived at a cost of equity of 18.96 percent," said the analysts.


Nigerian banks have been hard hit by the central bank strident regulations that are shrinking revenue and the coronavirus pandemic added to a new layer of concerns as the virus ballooned impairment charges on financial assets.

The regulator, in a bid to spur lending to the real sector, hiked the minimum loans to deposit ratio to 65 percent. But forcing lenders to extend credit to risky assets could lead to deteriorating asset quality.

Also, the decision by the central bank to bar individuals and corporates from its Open Market Operations (OMO) dealt a great blow to banks that rely on juicy yield to magnify profit.

Incessant demand to banks account for missing on cash reserve ratio (CRR) by the regulator is a torn in the flesh for operators in the industry.

Despite these monumental challenges, Analysts at Chapel Hill Denham forecast a 7.2 percent rise in earnings per share (EPS) to N7.34 in as at the end of the year (FY-21E) following higher net interest income and higher non-interest revenue.

## **Enterprise Value: Oando is** worth N349.09bn now

Oando Nigeria Plc, the second largest upstream oil and gas firm in the country, has an enterprise value of N349.09 billion.

That is the theoretical price an investor would pay to acquire the company, based on the market capitalization as at Friday.

Enterprise value (EV) is the market value of the equity plus net debt minus cash and cash equivalents, so unlike EPS it includes debt as well as equity in the valuation.

Many analysts also prefer the EV metrics because it cannot be easily manipulated like Price to earnings ratio. Price to earnings ratio relies on profit that can be manipulated by depreciations and exceptional items.

It is surprising that Oando has not released its 2020 audited financial statement and first quarter earnings season is gradually coming to an end as the markets await half year results.

Of course, the story of Oando is that of debt legacy as it has not recovered from the debt level built up through the 2014 acquisition of oil and gas assets from U.S. giant ConocoPhillips.

The vagaries of the crude oil market are the company's

greatest undoing, and crude oil prices crashed a few weeks after it bought the asset.

There was a moment of respite in 2017 when the price of the black gold rallied on the back of an aggressive output cut by Saudi Arabia and OPEC+.

The advert of the coronavirus pandemic undermined energy prices as countries were under lockdown while strict social distancing was observed.

In April 2020, the United States (ŪS) oil prices turned negative for the first time on record after producers ran out of space to store the oversupply of crude left by the coronavirus crisis, triggering an historic market collapse which left oil traders reeling.

However, oil prices have been rallying since the start of 2021, thanks to gradual reopening of economies and the successful roll-out of vaccines.

Brent crude rose by 0.61 percenton Tuesday evening to close at \$74.44 per barrel, the American Western Texas Intermediate (WTI) rose by 0.65 percent to close at \$72.59 per barrel, the Bonny light crude rose by 0.83 percent to close at \$73.26 per barrel, while the OPEC basket rose by 0.95 percent to close at \$71.99 per barrel.

There are concerns that the dangerously unstable oil market and the shift towards greener energy could leave Oando on a crossroad, and the highly geared balance exposes it to bankruptcy since the cash flows are pressured.

The company's operating income cannot cover interest expense as interest coverage ratio of 0.57 times, which is below the international benchmark of 1.50 times.

Interestingly, the oil and gas giant has reduced debt in its balance sheet as debt to equity ratio fell to 66.03 percent in September 2020 from 77.27 percent.

However, it has total debt (long and short term) of about N193.07 billion as at September 2020, and that is 9.83 percent lower than 2019's N214.14 billion.

A cursory examination of the financial statement of the company shows income tax credit the company has been enjoying for three years is responsible for it recording profit after tax; but such reliefs are exceptional items are oneoff events and do not recur too often.

MTN runs Nigeria's largest mobile phone network which generates around a third of the company's revenue. Also, Nigeria is MTN's most lucrative market out of the 22 countries the company operates in across Africa; Asia and the Middle East.

## Dangote \$2 billion urea fertilizer plant pushes out 120 trucks everyday

After months of speculation, Dangote Urea fertilizer is now finally on sale nationwide and it currently pushes out a minimum of 120 trucks per day across the country.

Group Executive Director, (Strategy, Capital Projects & Portfolio Development) · Dangote Industries Limited, Devakumar Edwin, revealed to the press over the weekend that the Plant which has the capacity to turn out more than 4,500 tonnes of urea per day will conveniently meet the local demand and even produce for exports.

According to him: "...We have the capacity to turn out 4,500 tonnes of Urea everyday...this is a bulk application fertilizer...each crop in Nigeria or globally will require Nitrogen and this is a rich fertilizer, having 46 per cent nitrogen... The company has the capacity to meet local demand and also export to African countries... Currently the demand is less than 1 million tonnes and we alone can produce 3 million tonnes, so we can easily meet local demand and also produce for export to other west African countries."

Aside from fertilizer production, the company, according to Edwin, is already working to support the farmers with training on application of the fertilizer and even establish laboratories across the country for proper soil examination.

'The uniqueness of this



we are producing is the focus on farmers' support, on training, education, development as we are now establishing laboratories across the country and even mobile laboratories where we can go drive around and take soil samples for proper examination to effectively grow the agricultural outputs across the country"

The Urea Fertilizer plant was built to tap into Nigeria's demand for fertilizer, a critical component of achieving food sufficiency for Africa's most populous country.

The Fertilizer plant is expected to manufacture 3 million metric tonnes of urea per annum, with a view to reducing the nation's fertilizer imports, and generating \$400m annual foreign exchange from export to Africa countries.

Meanwhile marketers and farmers in Kano have described the newly introduced Dangote Fertilizer as a game changer and a forecast for the expected agricultural revolution in the country.

Marketers and farmers who were apparently excited, over the weekend welcomed the more-than ten trucks that entered Kano markets at the weekend.

Enyo currently operates over 90 stations across Nigeria attending to over 100,000 retail customers daily across 15 states of the country, according to information released by the company.

# Life segment contributes 67.60 % to Industry premium income in 2020

The Life Insurance segment remains the lifeblood of the industry, with a share of total gross premium written at 67.60 percent, according to a latest report by Afrinvest Securities


The four largest life insurers-AIICO, Custodian, LASACO, and Mansard- collectively grew premiums by 16.13 percent to N87.13 billion, according to the research body.

Notably, the growth or grandiose performance was largely driven by benign regulations and low mortality from the coronavirus pandemic amid a surge in change in annuity life fund.

While the major players in the industry recorded minute losses in the aftershock of the virus, insurers in the European, United States, and Asian recorded high death rates.

"As one of the policies mandated by law, the life insurance segment continues to thrive on regulation as well as the option to purchase life annuity policies with pension proceeds granted by both PenCom and NAICOM," said analysts at Afrinvest Securi-

"The low death toll rate from the pandemic has been a posi-



tive for this sub-group compared with peers globally, where death toll has significantly resulted in huge claims payout. weak retention capacity of the Nigerian insurers would see more premiums ceded to reinsurers both home and abroad," said the

The largest 17 largest insurer collectively grew gross premium income by 17.33 percent to N327.39 billion in December 2020 from N279.01 billion as at December 2019, according data gathered by MoneyCentral.

Combined net premium income followed the same trajectory as it spiked by 14.84 percent to N205.48 billion in December 2020 from N178 billion the previ-

The life insurers suffered huge underwriting losses on the back of acceleration in change in annuity fund, but investment income and foreign exchange gains propelled them to the path of profitability.

Despite the pandemic that elicited a sit at home order by the government, Motor Insurance increased by 12.10 percent

to N13.80 billion as at December 2020.

There is room for improvement in this segment if more Nigerians adhere to mandatory third-party insurance policy.

Data from the Nigerian Insurers Association and the National Bureau of Statistics shows that only about 21.5 percent of vehicles in Nigeria are insured.

## N4.71 bn fair value loss on asset squeezes Mutual Benefit Assurance

Mutual Benefit Assurance Plc posted a huge net loss to start the year even as it maintained operating efficiency, not thanks to net fair value loss on assets.

For the first three months through March 2021, Mutual Benefit Assurance posted a loss after tax of N1.94 billion from a profit of N931.79 million the previous year.

The loss was largely driven by N4.61 net fair value loss on assets, which is a 950.12 percent surge from 2019's N449.78

The good tidings are that such transactions are one off events and do not recur at all times.

Fair value refers to the actual value of an asset - a product, stock, or security - that is agreed upon by both the seller and the buyer. Fair value is applicable to a product that is sold or traded in the market where it belongs or under normal conditions - and not to one that is being liquidated.

Mutual Benefit posted N3.16 billion in underwriting profit higher than 2020's N2.55 billion.

In 2020, the company secured the approval of shareholders to raise N4.80 billion by way of private placement to help mitigate the effect of the coronavirus pandemic and shore up capital in readiness for the recapitalization deadline by the regulator.

The coronavirus pandemic that tipped the country into its second recession in 5 years in 2020 slowed the pace of growth for the insurance industry, adding to another layer of myriad of challenges bedeviling an industry with one of the lowest penetrations in sub-Saharan-Africa.

Insurers hammered by the pandemic are turning to capital raisings to underpin their balance sheet as they race to see who will emerge strongest when the outbreak subsides.

In the last two years, the biggest insurers in Africa's largest economy have approached their shareholders with plans to raise a combined N28.15 billion by way of rights issue, according to data gathered by MoneyCentral.

Further analysis of Mutual Benefit's financial statement shows gross premium income increased by 37.76 percent to N7.04 billion in March 2021 from N5.11 billion the previous year.

Net premium income was up 27.09 percent to N5.45 billion in March 2021 as against N4.28 billion the previous year.

The insurer paid N1.35 billion claims in 2020, which is 70.69 percent higher than 2020's N791.85 million the previous year.






## Egbin power seeks \$1.8 billion to expand output

Nigeria's Egbin Power Plc, the biggest in Africa's largest economy, plans to raise \$1.8 billion to more than double generation capacity as it seeks to boost output and export electricity to West African countries.

It is looking at a combination of debt and equity to meet the funding requirements ahead of the start of construction work in the second quarter of next year, according to the company.

"The plan is to raise the fund to be available to kick off," it told Bloomberg, without giving more details as the funding arrangements are being firmed up.

Egbin Power Plc, owned by Sahara Group, plans to build the second phase of its 1,320-megawatt power plant



by installing "high efficiency gas combined cycle power plants," that will produce an

additional 1,754 megawatts of electricity. The first phase of the expansion project will begin with the construction of open-cycle turbines next year and will be completed with a closed cycle by 2025, it said.

The company acquired the power plant in 2013 when the government disposed of stateowned electricity generation and distribution assets to the private sector to make them efficient and help curb blackouts. It hit the generation peak of 970 megawatts on the asset this year helped by an increase in gas supply.

Africa's largest economy has 13,000 megawatts of installed electricity-production capacity, with only about 4,500 megawatts dispatched to the grid daily, in part because of dilapidated transmission infrastructure. The government's privatization agency is now proposing to sell the transmission network in a bid to attract the investment needed to improve its

The government of President Muhammadu Buhari is targeting improved electricity supply as a priority for the West African nation, where poor maintenance and a lack of investment has left the population of about 200 million chronically under-served.

Besides boosting local supply, Egbin plans to sell power to neighboring countries through the West Africa Power Pool, a specialized institution of the Economic Community of West African States established to create a common electricity market for the region, the company said. "We would have a stateof-the-art facility that is generating clean energy sustainably and paving the way for seamless energy transition in Nigeria and beyond."

## NDDC has failed, not living up to its responsibilities, Obaseki insists

The Edo State Governor, Mr. Godwin Obaseki, has restated that the Niger Delta Development Commission (NDDC) is not living up to its responsibility of ensuring infrastructural development in the Niger Delta and raising the standard of living of the people.

Obaseki said this on Thursday when he received the Odiowere and elders of Ugha Quarters of Urhonigbe Town in Orhionmwon Local Government Area, who were on a courtesy visit at the Government House, Benin

The governor, represented by his Chief of Staff, Hon. Osaigbovo Iyoha, reassured that his government will sustain ongoing infrastructure projects across the state to boost economic activities and improve the lives of the people.

He said: "We are aware and know that the road has been awarded by NDDC. We make sure that we don't duplicate efforts. NDDC has not been forthcoming with contracts that have been awarded at that

"In a normal system, if the NDDC has lived up to their responsibility and done the right thing, the government will not need to do the same project. We don't duplicate work;

it amounts to a waste of funds."

"NDDC left the road in a worse shape than it was before the construction started. It is not an excuse to allow the people suffer, following the failure of an agency to perform their statutory responsibility," he added.

Obaseki continued: "As soon as possible, we would send government agencies to check the immediate state of the road and report back. We will do something quick for our people at Urhonigbe because we know that our people are predominantly farmers.

"We would deploy officials from the Ministry of Infrastructure to examine the state of the road to enable us to provide palliative measures before providing a permanent solution to the road. As an administration, we will do our best to ensure that the people of the community feel the impact of the government."

Appreciating the people of Ugha Quarters for the support before, during and after the governorship election in the state, the governor noted: "I appreciate you for your support and prayers before, during and after the election, as well as your support throughout the time in the courts.

"The last election proved to us that you trust this administration and I want to assure you that the confidence reposed in us will not be betrayed. We will deliver the dividends of democracy to the people of the State, including Ugha Quarters in Urhonigbe.

"As a candidate, I visited the 192 wards of Edo State and know what the people want; I am prepared to ensure that we improve the standard of living of

our people."

## Saudis warn oil price surge could follow reduced global crude exploration

A new supercycle in global oil prices could be triggered by a lack of new investments in exploration, Saudi Arabia's energy minister said.

Prince Abdulaziz bin Salman, who's been warning speculators of the hazards of bearish bets, told the Robin Hood Investors Conference last week that his job is to prevent such a supercycle, according to people familiar with his comments.

The comments mark an attempt by Prince Abdulaziz to reach out directly to Wall Street, speaking to an audience of hedge funds in rare move for a Saudi royal. Previous oil ministers tended toward closed-door discussions with influential market voices such as commodity hedge funds.

"I think it's my job, and others' jobs, to make sure this super-cycle doesn't happen," the prince said.

He also warned that there is a risk of a supercycle due to "lack of investing."

After back-to-back oil busts, some national oil producers and international exploration companies have scaled back drilling budgets to conserve cash and avoid a new supply glut.

The prince is among those who worry the reductions may have gone too far and lead to a tightening of crude supplies as demand rebounds.

International crude futures have surged 43 percent so far this year, on track for the strongest annual performance in half a decade as economies emerge from pandemic lockdowns and major exporters exercised restraint in lifting oil output.

Benchmark Brent futures rose as much as 1 percent to almost \$75 a barrel on Wednesday, the highest price since April

# Ebrahim Raisi poised to win Iran's presidential election

Preliminary tallies by the interior ministry showed that Raisi received nearly 18 million votes out of 28 million total ballots cast, according to the semi official Fars news agency.

His nearest rival, Mohsen Rezaei, received 3 million votes. Iran has roughly 64 million eligible voters, including citizens overseas. Deputy interior minister Jamal Orf said 90 percent of votes had been tallied so far.

Official results were expected to be released later. Raisi's win, if confirmed, solidified control by Iran's hard-liners over all of the country's ruling institutions, including the executive branch.

Raisi, 60, a fixture of Iran's conservative establishment and an acolyte of Supreme Leader Ayatollah Ali Khamenei, currently serves as chief



of the judiciary. Human rights groups have linked Raisi to episodes of repression over decades and said he played a central role in mass killings of dissidents in the late 1980s.

He will replace President Hassan Rouhani, a relative moderate whose government signed the 2015 nuclear accord with the U.S. and other world powers, and later, was subjected to the Trump administration's "maximum pressure campaign" aimed at crippling Iran's economy using sanctions and other measures. Trump withdrew the U.S. from the nuclear accord in

### White House denies pausing military aid package to Ukraine

The White House on Friday denied holding back security assistance from Ukraine hours after a Politico article said that officials had paused a package including lethal assistance worth up to \$100 million.

White House press secretary Jen Psaki issued a statement Friday afternoon calling the idea that the White House has held back security assistance to Ukraine "nonsense."

Psaki cited a \$150 million aid package announced by the Defense Department last week and pointed to President Biden's public support for Ukraine in the face of Russian aggression ahead of his summit with Russian President Vladimir Putin on Wednesday.

"We have now provided the entire amount appropriated by Congress through the Ukraine security assistance initiative," Psaki said.

'We have also prepared contingency funds in the event of a further Russian incursion into Ukraine. As President Biden told President Putin directly, we will stand unwavering in support



for Ukraine's sovereignty and territorial integrity."

Politico, citing four anonymous sources, reported on Friday that the White House temporarily froze a military assistance package to Ukraine that was meant as a response to Russian troop build up on the border with Ukraine earlier this year.

The package was reportedly put together but halted when Russia said it would draw down troops on the border with Ukraine, the report said.

The decision by the Biden administration to halt the package was first reported by The Washington Post earlier this week, but Politico's report included further details, including saying that the National Security Council was the source of the decision to halt the funds.

The article was met with criticism from several Republicans, some of whom equated it to the Trump administration's freezing some \$400 million in military aid to Ukraine in 2019. Trump was impeached that same year on a charge he abused his power by withholding the assistance to try to force Ukraine to investigate then-candidate Biden and his son Hunter Biden's dealings in Ukraine.

consolidation 2005 will be replicated soon.

The market had anticipated the recapitalization exercise launched by the Nigerian Insurance Association (NAICOM) in 2019 would accelerate mergers and acquisitions, but the outbreak of the coronavirus pandemic that forced the government to impose lockdown measures significantly halted deals in 2020.

The initial deadline for recapitalization was set as June 2020 and NAICOM had approved the recapitalization plans of about 44 insurers (of which 6 were Mergers and Acquisitions) as at August 2019 while rejecting 6 companies' plans and placing 2 others under

There have not been any major deals in 2021 even as the government is gradually reopening the economy on the expectation of rollout of vaccination.

However, companies were raising capital via rights issues to strengthen their capital with a view to meeting the recapitalization guideline by the regulator.

In the last two years, the biggest insurers in Africa's largest economy have approached their shareholders with plans to raise a combined N28.15 billion by way of rights issue, according to data gathered by

MoneyCentral.

The industry now consists of 58 insurers; 13 composite insurers, 31 general insurers and 16 life insurance companies after NAICOM cancelled UNIC Insurance plc operational license in April 2021 due to solvency and poor operational performance.

#### Here are some companies up for grabs STACO INSURANCE **PLC**

Staco insurance Plc has not released its financial statement on the bourse since 2018, and the company is technically insolvent.

For instance, it has accumulated losses of N182.43 million as at September 2018, which means it has been recording net losses for the most part of its existence; perhaps more worrisome is a negative shareholders' fund of N182.43 million, a harbinger of technically insolvency.

Staco Insurance is op-

erational inefficient as it is paying out in claims more than it is earning in revenue, which beckons on its owners to look inwards and introduce products that are market friendly.

The combined ratio has broken the scale, exceeding the 100 percent threshold. The ratio deteriorated to 119.16 percent in September 2018 from N105.74 billion the previous year.

Staco Insurance is notorious for breaching regulatory rules as it was suspended in 2018 for failure to file a corporate account as at when due, but it has not even filed one since

#### then. **GUINEA INSURANCE**

The going concern status of Guinea Insurance is under jeopardy, and something urgent has to be done by management and board of directors to salvage it from going bust.

Its combined ratio stood at 145.10 percent as at March 2021, while management expenses of N166.62 million is 84.13 percent of net premium of N198.11 million.

It has accumulated losses of N1.97 billion in the period under review.

#### **NIGER INSURANCE**

Niger Insurance Plc earnings have always been swallowed by claims and management expenses that have eroded profitability. It has little time to clean its books before the deadline of recapitalization having accumulated losses of N7.79 billion as at December 2020.

It incurred N1.56 billion in claims, which is 1.71 times net premium income of N914.92 billion; similarly, management expenses are 1.43 times revenue.

The insurer is one of the oldest in Nigeria, but it is living on past glories as the new generation companies have a better risk manage-

ment strategy and they are able to deploy resources in acquiring the latest technology that helps in bolstering cost optimization.

#### INTERNATIONAL EN-**ERGY PIC**

International Energy had obtained approval from Nigerian Insurance Commission (NAICOM) to engage the proposed buyer in a bid to meet the recapitalization guide line.

This is undoubtedly a smart move by the owners of the beleaguered company that is at the cusp.

It is not surprising that the owners threw in the towel as they have come to the realization that the company needs fresh capital injection to wipe-out the losses.

The insurer is reeling from recurring losses as it has negative retained earnings of N40.52 billion as of September 2020 in its capital structure.

It is not surprising that the insurer's total liabilities of N57.80 billion exceeds the total asset of N40.91 billion, which resulted in negative retained earnings of N13.86 billion, according to Money-Central calculations.

Despite N6 billion realized from investment income, the company posted a loss after tax of N3.20 billion.

The insurer shrugged off the fear that the Covid-19 crisis as its solvency margin stood at 987 percent in December 2020, nat compares with AIICO Insurance, 351 percent; NEM Insurance, 412 percent, AXA Mansard, (454.50 percent), and Consolidated Hallmark, (238.60 percent).

LEADWAY Assurance has a total asset of N525.43 billion as at December 2020, which is the largest among peers.

#### AllCO Insurance is largest by premium income

AIICO Insurance is the largest company by gross premium income in Africa's largest economy, which validates its market penetrating products.

There were increases along the life and non-life segment, and there are expected that revenue will increase in 2021 on the back of rebound in economic activities.

The insurer posted gross premium income of N60.70 billion as at December 2020, and that compares with Custodian Investment, (N58.14 billion); FBN Insurance, (N47.08 billion); AXA Mansard Insurance, (N45.11 billion), and NEM Insurance, (N20.98 billion).

#### FBN Insurance has the strongest ROE

FBN Insurance has delivered more returns to its shareholders than any insurer in the country. If the insurer were a listed entity, it would have an attractive valuation.

What this means is that FBN Insurance has utilized the resources of shareholders in generating higher profit.

 $It\,recorded\,return\,on\,equity$ of 41.55 percent as at December 2020, and that compares with AIICO, 19.51 percent; NEM Insurance 23.48 percent; Custodian Investment, 22.23 percent; Mutual Benefit, (18.73 percent); AXA Mansard, 12.70 percent.

#### **NEM Insurance has low**est combined ratio

NEM Insurance has the lowest combined ratio among peers, which means it's able to earn more in revenue than it pays out in claims. The lender's cost control mechanism helped bolster operational efficiency even amid inflationary pressures, incessant devaluation, and decrepit infrastructure.

Its stellar underwriting performance relative to peers is desirable and the Company is now well-capitalized and poised for sustained growth.

Analysts at Afrinvest Securities are of the view that it is poised to continue to deliver strong numbers into the foreseeable future.

The company that has been paying steady dividends and sustaining underwriting profit is the toast of many investors who find its valuation attrac-

#### **Custodian Investment** emerges as the most capitalized and profitable

Custodian Investment is the most capitalized insurer in Africa's largest economy.

It has market value of N34.99 billion as of 2:00 pm in Lagos, and that compares to AXA Mansard (N34.40 billion); AIICO, N22.53 billion; Consolidated Hallmark, N8.53 billion; NEM Insurance, N7.17 billion; Coronation Insurance, (N13.11 billion), and Mutual Benefit Assurance, 5.02 billion.

#### **AXA Mansard Maintains** strong operating efficiency

Despite the tough operating and challenging environment, AXA Mansard's combined ratio of 99.98 percent was within the international benchmark as the insurer's return on equity is growing faster than total operating expenses.

The insurer's HMO business would continue to be the major driver of growth, thanks to increased awareness on health insurance benefits.

More importantly, the company is spending less on claims and expenses in generating premium income, and its attractive valuation is an opportunity to buy into the stock.

Claims expense ratio fell

to 62.86 percent in December 2020 from 66,53 percent the previous year; management expense ratio reduced to 25 percent in the period under review from 30.61 percent as at December 2019.

As the company is sufficiently capitalized and pious to meet the recapitalization deadline, it is expected the stellar operating performance will be maintained.

In their coverage universe, analysts at Afrinvest Securities see significant upside in Mansard. Their optimism stemmed from the insurers' strong risk management among composite insurers and the positive effect of the termination of the annuity funds on bottom line.

#### Outlook for the industry

We expect the top line of these big six insurers to remain strong on the back of the roll out of vaccines and relation of social distancing.

Since the Life segment recorded lower mortality or death rates due to the coronavirus pandemic compared to global peers, they are expected to magnify earnings this year. Also, the general business will see growth on the back of compulsory third party insurance and good regulations capable of unlocking the potential in the sector.

There are indications that the Holdco structure adopted by banks will underpin mergers and acquisitions as there are too many weak insurers waiting to be taken over.

Recall that Heirs Holdings Group made an inroad into the insurance space with the launch of two firms: Heirs Insurance Limited, and Heirs

#### It is said in some quarters that almost 99% of Nasarawa state youths are Jobless; what is your take on this?



# Drug makers profit margins soar on pandemic boost

Drug makers in Africa's largest economy are generating and retaining money in their business as the coronavirus pandemic forced consumers to spend more on health and essential commodities.

That resulted in a sharp jump in profit margins, which indicates financial stability needed for shareholders to be rewarded for being risk takers.

The growth recorded in the industry stemmed majorly from the impact of the pandemic which forced a change in the lifestyle of people, thereby pushing consumers to spend more on drugs to keep them safe and healthy.


The average gross margin of the dominant players in the industry-Fidson HealthCare Plc, May and Baker Plc, and GlaxoSmithKline Nigeria-increased to 39.13 percent in March 2021 from 33.33 percent in 2020, according to data gathered by Money-Central.

This is a key indicator of the strength of its manufacturing and product pricing. A high gross profit margin indicates that a company is successfully producing profit over and above its costs.

The drug makers are earning more per Naira of sales while returning higher returns to shareholders.

Their combined average net profit margins grew to 3.81 percent in March 2021 from 2.89 percent in 2020, 1.84 percent in 2019, and 1.58 percent in 2018, according to data gathered by Money-Central

Each of the companies have magnified both sales and profit, which validates management and board of directors' focus market pen-



etration strategies that has enabled their firms surmount the macroeconomic head-

Notably, the three firms saw cumulative net income surge by 91.04 percent to N588.86 million in March 2021 from N308.23 million the previous year.

The three firms collectively grew revenue by 18.11

percent to N12.48 billion in 2021 from N10.57 billion in 2020; sales increased by a mere 1.14 percent to N10.57 billion in 2020 from N10.42 billion in 2019; it was up 4.13 percent to N10.42 billion in 2019 from N10 billion in 2018; It was up 3.87 percent to N10 billion in 2018 from N9.63 billion in 2017; sales surged by 33.91 percent to N9.63

billion in 2017 from N7.19 billion in 2016.

Nigeria's drug-manufacturing companies have struggled to source raw materials and imported inputs because of a foreign-currency squeeze caused by the plunge in income from oil that was exacerbated by the advert of the coronavirus pandemic.

The majority of Nigerians

cannot afford drugs as inflationary pressures have eroded their purchasing power as the cost of healthcare continues to spiral up.

Healthcare cost, which is an inconspicuous driver of core inflation, rose by 15.8 percent year on year (y/y) and 1.1 percent month on month ( m/m), according to the latest inflation figures released by the National Bureau of Statistics (NBS).

In the five years preceding May 2020, the Health care sub-index of the core inflation grew at an average rate of 10.0 percent. Following the Foreign Exchange (FX) concerns in 2020, healthcare cost has been on the rise.

The rise in the cost of pharmaceutical products, medical services, dental services, paramedical services, and hospital services have jointly accounted for the 15.8 percent (y/y) rise in health care cost in the last 12 months ending May 2021, according to analysts at CSL Stockbrokers Limited.

"In our view, cost, and


accessibility of healthcare services in Nigeria must be an area of focus for the government and we believe both public and private sector participation will be required," said the analysts.

The International Monetary Fund and the World Bank have urged the central bank to adopt a unified foreign exchange system that will spur economic growth and pave the way for businesses to thrive.

Fidson Healthcare has a price to earning ratio of 7.18 times and dividend yield of 4.90 percent; its share price closed at N5.10 as of 2:00 pm Lagos, valuing it as N10.64 billion.

May &Baker trades at N5.96 times earnings and dividend yield of 7.28 percent; its share price closed at N4.04 as of 2:00 pm in Lagos, valuing it at N6.97 billion.

GlaxoSmithKline has a price to earning ratio of 13.10 times with a dividend yield of 6.67 percent; The drug maker's share price closed at 2:00 pm, Friday, valuing it at N7.27 billion.

## Lack Of Inter Agency regulations affecting international trade In Nigeria

The Director - General of Lagos Chamber of Commerce and Industries (LCCI), Muda Yusuf has disclosed that lack of inter-agency regulatory framework is affecting the implementation of international trade in the country.

Yusuf asserted this in Lagos during the 3rd Annual Lecture and Awards of the Primetime Reporters; with the theme: "Assessing Nigeria's Readiness to Maximize the Gains of AfCFTA."

In his remarks, he further said that some agencies operate as monopoly, affirming that the sector lacks dispute resolution mechanisms to tackle issues confronting the Industry.

While speaking, Yusuf listed cost-effective power supply, cost of credit (interest rates), expanding trade finance/micro credits and finance for Small and Medium Enterprises Development (MSME) as some of the problems faced by stakeholders.

He added that multiple taxations by government, high

level of insecurity, quality of trade infrastructure, long-standing problem of transshipment, piracy, smuggling, and other injurious trade practices by non-African trading partners also contribute to international trade road-blocks in the country.

He however, urged that African Continental Free Trade Act would be beneficial for SMEs in Nigeria, as it also comes with other benefits including developing infrastructure to support local production and export capacity.

## Dangote Sugar leads the pack as best consumer goods stock

While consumer spending is expected to remain subdued on the back of macroeconomic headwinds, the margin of Dangote Sugar Refinery is expected to remain resilient as it is able to take much higher price increases than peers.

That means this stock should be added to the portfolio of savvy investors as the company has an attractive valuation, which means it can outperform the broad market this year.

Dangote Sugar Refinery (DSR) is a value stock, and the fact that it produces essential items gives it the leeway to ride out of an economic downturn.

A value stock refers to shares of a company that appears to trade at a lower price relative to its fundamentals, such as dividends, earnings, or sales, making it appealing to value investors.

A value stock is trading at levels that are perceived to be below its fundamentals.

The above is true about the largest producer of the sweetener in Africa's largest economy that has been delivering higher returns to its shareholders.

For instance, it is the highest paying dividend stock in the consumer goods industry.

Dangote Sugar has a dividend yield of 8.47 percent, and that compares with Flour Mills



Nigeria (4.71 percent); Nigerian Breweries, (1.61 percent); Nestle, (4.32 percent), and Cadbury (2.21 percent).

The dividend yield, expressed as a percentage, is a financial ratio (dividend/price) that shows how much a company pays out in dividends each year relative to its stock price.

Its low price to earnings ratio reiterates the attractiveness of the stocks.

DSR trades at 7.26 times earnings, that compares with peer rivals that are ridiculously overpriced. Nestle has a price to earnings ratio of (63.18 percent); Nigerian Breweries, (63.18 percent); Cadbury, (84.43 percent); Nascon Allied, (8.36 percent), and Honeywell, (16.46 percent).

Despite the coronavirus pandemic that tipped many countries into recession, the worsening Apapa gridlock and the insecurity challenges across the country, DSR has seen margins improved on the back of robust sales growth.

Sales spiked by 41.14 percent in the first three months of March 2021; operating margins increased to 23,57 percent in March 2021 from 22.56 percent the previous year. Also, the producer of the sweetener is turning each Naira invested in sales into higher profits.

#### **Dangote Sugar maintains** leadership position

Dangote Sugar leads the sugar industry with 61.5 percent market share and production capacity of 1.44mmtp/a, a feat it has been able to achieve through pioneer advantage, long-standing presence in the market, large production capacity, volume driven marketing strategy, strong distribution and delivery

#### Favorable demographic, a boon for Dangote Sugar

Nigeria's huge population that craves for consumption is a boon for the company and portends positive prognoses of future earnings growth.

Nigeria currently offers a market of 200 million people projected to expand to 264 million and 410 million by 2030 and 2050 respectively, according to the World Bank.

This indicates a growing market and demand for consumer goods products, especially for consumer staples with high demand.

The company stands to benefit from this demographic advantage through its network of institutional customers across the beverage, biscuit, bakeries and confectioneries subsections among others that utilize sugar as inputs to produce final staple

#### **Backward Integration to** underpin margins

Dangote Sugar is committed to the implementation of the Nigeria Sugar Master Plan that was launched in 2012 and the company designed its own master plan in 2013. The backward integration programme, which is paramount on the company's strategic plan, has huge profit potentials for the producer of the sweetener.

The company said its Backward Integration goal is to become a global force in sugar production, by producing 1.5M MT/PA of refined sugar from locally grown sugar cane for the domestic and export markets.

To reduce the country's huge import bills that are increasing stocking trade deficit and undermining economic growth, Dangote Sugar is committing \$700 million to various sugar projects across the country.

The aim of these projects is to make Nigeria self-sufficient in sugar and promote infrastructure that will accompany the sugar project.
