Nigerian quoted companies' balance sheets are looking better, which validates their abilities to pay interest on debts even as market participants expect the central bank to hike interest rates to tame rising inflation.

The median interest coverage ratio for companies stood at 4.52 at the first quarter of 2022, however it is lower than the 8.10 recorded in 2021, according to data compiled by MoneyCentral. The figure is a measure of a company's ability to repay its debts, with a ratio of at least 2 generally considered the minimum acceptable amount for a company with solid revenues. Analysts typically prefer a coverage ratio of 3 or higher.

Interestingly, the combined interest expense or finance cost which these entities pay on money borrowed from banks was down 18.17 percent to N83.20 billion as at March 2022.

The improved financial health among firms comes as the Monetary Policy Committee of the Central Bank of Nigeria (CBN) is expected to hold its

third meeting of the year on the 23rd and 24th of May 2022.

Analysts at Cordros Securities in a note to clients say they do not rule out the possibility of a 50 basis point hike in the Monetary Policy Rate (MPC) given the hawkish rendition among global central banks and the indirect impact of the Russian/Ukraine crisis on domestic inflationary pressure.

The central bank policymakers have held the MPR at 11.50 percent, stating the need to attract foreign direct investment and price stability as the major Continues on page 15

NATIONAL **FIRS terminates uniform withholding** tax rate for residents of treaty countries

The Federal Inland Revenue Service (FIRS) has issued a Public Notice informing taxpayers of the termination of the reduced 7.5% withholding tax (WHT) rate applicable on dividends, interest and royalties earned by taxable person's resident in countries with Double Tax Agreements (DTAs) with Nigeria.

The FIRS noted that the termination follows the approval of the Honourable Minister of Finance, Budget and National Planning(HMoFBNP)todiscontinue the unilateral application of a uniform 7.5% WHT rate deducted on dividends, interest and royaltiesearnedbyresidentsofits treaty partners under the DTAs with Nigeria. Consequently, effective from 1 July 2022, the applicable WHT rates on the above incomes will be the rates specified in the relevant tax laws,

the respective DTAs. Based on the foregoing, the FIRS has issued an updated Information Circular No.: 2022/15 on The Claim of Tax Treaties Benefits and Commonwealth Relief in Nigeria.

The Circular, which replaces the FIRS Information Circular No. 2021/05 issued on 3 June 2021, retains the clarifications on available tax treaty benefits provided in the erstwhile Circular, and introduces additional information on the new applicable WHT rates, requirements for permanent establishments (PE) in Nigeria, and guidelines for the claim of Commonwealth Tax Relief (CTR) under Section 44 of the Companies Income Tax (CIT) Act.

The FIRS noted that the government policy statement on unilateral reduction of WHT rate to 7.5% contained in the 1999 Budget Speech was not promulgated into a Decree and published in the Official Gazette of the Federal Government. Consequently, there is no legal basis for the reduction of the applicable WHT rates to taxpayers' resident in the treaty countries. Further, the FIRS argued that relevant protocols were not executed between Nigeria and the treaty partners to mandate any reduction in the WHT rates specified in the relevant DTAs.

Banking fraud amid increasing biometrics adoption

Nigerian banks and their customers still lose billions of naira to fraudsters, despite security measures emplaced to check such, writes EHIME ALEX

To fight banking fraud at Point of Sale terminals and Automated Teller Machines across payment ecosystems in Nigeria, Interswitch, a digital payments solution provider, recently announced plans to roll out a new solution designed with advanced biometric features. This comes as many Nigerian banks are faced with increasing fraud cases year-on-year.

Findings by Financial Street shows that fraud cases reported by four Nigerian banks to the Central Bank of Nigeria rose by 166.12 per cent to N7.199tn in December 2021 from N2.71tn in December 2020.

This is according to the 2021 audited financial statements of Access Holdings Plc, Guaranty Trust Holding Company Plc, Fidelity Bank Plc and Sterling Bank Plc.

Sterling Bank reported the highest figure rising by 1613.77 per cent to N3.35tn in 2021 from N195.34m in 2020. Access Bank followed with N1.99tn in 2021 from N1.02tn in 2020. While the value reported by GTCO rose slightly by 10.75 per cent to N1.21tn, Fidelity's rose by 381.498 per cent to N650.88m.

The latest report by Check Point Research Threat Intelligence on Nigeria puts the number of attacks experienced per business each week, collectively, at 2,308 across all industry sectors, adding that the figure is higher still for businesses in the financial sector.

Thus, considering the reliance of banks on Information and Communications Technology to operate their business and the rising incidence of cyber threats and attacks targeted at financial institutions, banks should be driving their credit risk management processes using appropriate scalable technology to achieve global best practices. Cybercrime techniques

A number of techniques are

being used by scammers to defraud unsuspecting banks' customers, including phishing, hacking, malware, identity theft and ATM spoofing. Not to mention social engineering, which involves manipulating people to give out sensitive information, fraudsters use several other techniques, from card theft to Personal Identification Number compromise, in carrying out their acts.

In 2019, the CBN confirmed that transaction valued at N6.5tn was stolen from commercial banks in Nigeria by hackers. Between 2014 and 2017, the banking industry lost N12.30bn to various frauds. Between January and September 2020, more than N5.04bn was lost to fraud in the banking sector, and increased by 34 per cent to N7bn in the same period of 2021, the Nigeria Inter-Bank Settlement System Plc disclosed in its report on 'Fraud in the Nigerian Financial Services'.

Use of biometrics

As far back as 2018, the CBN had planned to ditch ATM pin codes and replace them with biometrics to streamline and add more security to the process. That thought, as logical as it was as a solution for preventing fraudsters from stealing data from customers of the bank, especially among the illiterate and older customers, who may require help to use the ATM or PoS, the move has hardly been widespread, existing just in silos. Huge investment

Artificial Intelligence is a

potential solution, but it comes with challenges ranging from cost, limited resources, talent shortage and lack of systems. As a result, only 25 per cent of the institutions surveyed by PricewaterhouseCoopers, a multinational professional services network of firms, are using AI.

While banks strive towards enhancing cybersecurity resilience in digital financial services, continuous and regular cybersecurity awareness for consumers should be prioritised. This is even as developers said that the benefits of making effective use of biometrics outweigh the operational cost.

According to a report released in March 2022 by the Carnegie Endowment for International Peace, "It will require the financial institutions to invest significantly in, and have a robust capacity development plan for, their information technology and cybersecurity teams and top executives, as the financial sector is highly susceptible to cyber attacks, and new kinds of attacks are launched regularly, so capacity building must be frequent and consistent."

Leveraging digital offerings

The Nigerian digital financial ecosystem has witnessed remarkable growth in the past few years, according to McKinsey & Company, a management consulting firm. The country is home to over 200 fintech organisations, not counting fintech solutions provided by banks and mobile network operators.

New service providers range from mobile money operators and payment service providers to fintech firms and other financial services providers, a trend that is increasing the need to ensure consumer security and trust.

These services come with numerous important digital components, including mobile applications, digital tokens, Unstructured Supplementary Service Data, and digital ledgers, all of which comw with potential vulnerabilities, according to a report by the Carnegie Endowment for International Peace released in March. "It is increasingly important for the country's financial industry to prioritise cyber security, as it is the most targeted sector for cyber attacks.

'Over the last six months, the number of attacks against banks and other institutions in Nigeria was 3,682 per week, while globally, this figure is far lower at 774, Check Point Software Technology Regional Director for Africa, Pankaj Bhula, stated recently. "To protect this booming industry, more must be done to drive awareness around cybersecurity."

Keeping with regulation

The CBN, in line with its regulatory powers and oversight functions under the CBN Act and the Banks and Other Financial Institutions Act, has taken salient steps towards regulating this space by striving to strengthen the cybersecurity defences of banks and non-financial institutions.

The instruments for doing so

include documents like the Risk-Based Cybersecurity Framework and Guidelines for Deposit Money Banks and Payment Service Providers, the Risk-Based Cybersecurity Framework and Guidelines for Other Financial Institutions, the Regulatory Framework for Mobile Money Services in Nigeria, and the Nigerian Payments System Risk and Information Security Management Framework.

The CBN also collaborates with relevant stakeholders such as the Securities and Exchange Commission to develop market regulations for cryptocurrencies and the Nigerian Communications Commission - the telecommunications sector's regulator - to regulate mobile money operations.

Cybersecurity remains a crucial pillar in Nigeria's National Digital Economy Policy and Strategy, which outlines a vision for diversifying the country's economy. The 2021 Nigerian National Cybersecurity Policy and Strategy identifies the banking, finance and insurance sector as one of its 13 critical information infrastructure sectors.

Last line

The effect of cyber crime on commercial banks are huge financial losses, despite the assumption losses declared by banks yearly. It is unfortunate that this incident is hidden from the public in order to protect investors and customers from being alarmed and to protect their reputation. However, commercial banks are continually faced with huge losses and how they recover from these losses is still a misery.

ANALYSIS Africa Tech & Fintech What's bubbling under – April 2022


Last month, we led CFA Nigeria's breakfast session on the valuation of fintech companies - please view the recording and slides. Through the month, we paid attention to private market valuation trends. From Forge Global, a NYSE-listed trading platform for private shares, we learnt that prices for companies that traded on it in both 4Q21 and February/March 2022 have fallen by 19.9% vs 38% and 26% for the Renaissance IPO Index and NASDAQ 100 Technology Index respectively. On its 1Q22 call, VEF CEO, David Nangle, noted that VC conservatism kicks in during these cycles as capital becomes more precious, IRR hurdle rates rise, and startups become price-takers though they have some tactical strategies they could deploy. More comments from GP Bullhound and Novastar in the note. Separately, we listened to some African fintech discussions, including the fintech revolution in Africa's FX markets, the Africa Fintech Summit in DC and Ecobank's fintech breakfast series. We also released a thematic report on tech/ fintech M&A action in Africa and how incumbents could respond, as well as other notes on Stitch (API fintech/open banking), ZirooPay(offline acquirer+) and Khazna (Egyptian neobank). Looking at funding trends, April had a notable slump, reaching \$437mn (down 39% MoM, though still up 139% YoY), 60% of which was Sun King's \$260mn Series D. We wondered if this was a one-off or an indicator of weaker months ahead. In this note, we highlight some M&A trends in the African tech ecosystem, implied listed fintech and mobile money valuations, and what we've been reading this month.

What the pros are saying about private market valuations

While global venture funding is slowing, the African tech scene had a busy first quarter. However, for the first time since December 2021, fundraising in the African tech scene slumped, as startups during April raised c. \$437mn (down 39% MoM, though still up 139% YoY) across 57 deals (down 44% MoM and 17% YoY). YtD. ~\$2.2bn has been raised across 300+ deals. Fintech continued to hold sway, accounting for c. 35% of the YtD raise. On a MoM basis, Nigeria and South Africa each saw their share of YtD funds raised decline by 3 ppts each, while Egypt was unchanged. However, Kenya gained 6 ppts on a MoM basis, buoyed by Sun King's \$260mn series D raise. But what are the pros telling us?

Forge Global: Private companies are rethinking their exit strategies, driven by cancelled SPACs, delayed IPOs and private companies reducing their own internal valuations. Thus, more private shareholders and companies are turning to private markets to find near-term liquidity solutions.

"43% of sellers are offering stock at an average 21% discount to the last fundraising round valuation, and 49% of buyers are seeking to




buy stock at an average 24% discount to the last fundraising round valuation," said Forge Global. Overall, 60% of indications of interest on its platform are coming from sellers, and 40% from buyers. It's a buyer's market. Buyers are doing more homework on companies they like for the long term, at potentially more attractive valuations across different sectors: data software, sales and business software, payments and cyber security.

For employee shareholders, it takes some time for them to lower their valuation expectations but it's happening as public valuations reduce.

VEF (listed EM fintech VC fund): VC conservatism kicks in during these cycles as capital becomes more precious, IRR hurdle rates rise, and startups become price-takers. VEF has a 30% IRR usually, but is now asking for 40% IRR because if you can find such cheap public investment opportunities, why pay more for a private company? VEF will look for better and deeper-value opportunities. The slowdown is mostly in later-stage companies. However, this is not a good environment to be raising capital because of valuation pressures. As the need to raise funding picks up through the year, some companies may have to consider redundancies or raise debt to tide them over. We may nonetheless see some going bust. Positive and improving unit economics are quite important in these times, with a clear path to profitability. In this market, companies are price-takers, but quality companies will still raise funding as there's still capital to deploy. Nowadays, VEF is focusing on strategy and extending runway for its portfolio companies by telling them that if they need to raise capital in 1Q23, they need to do it much sooner, or if they last raised in 4Q21, they need to do an extension round sooner which is happening. Local VC funds are well set up in emerging markets, so there's still a lot of dry powder. For VEF, earlystage opportunities abound. Public funds have been drifting into the private space, and maybe these are the ones pulling back a bit and in risk-off mode at the moment.

GP Bullhound (private techfocused investment bank): Public software valuations using a cohort of revenue multiples have moved from 17-20x to 7-9x on average over




the past few months. In private markets, using M&A and investing deals, multiples haven't corrected by nearly as much. On the M&A side, valuations are still robust. There will be a migration because it's unsustainable. IPOs were happening because tech had such a good run, but IPO markets are now closed and this will have knockon effects. But there's still significant dry powder in private funds. The question is what's the right valuation and this could take six-toeight months to settle. Investors are now looking for real category and long-run winners. For those living on hyped slides, they will struggle. Have we reached a bottom? The near-term macro clouds suggest no. Unprofitable and big tech have suffered the most.

In B2C software advertising and consumer solutions, there's real demand weakness driven by geopolitical issues, inflation etc., so there's a long way to reach the bottom. In B2B, looking at recent reporting season feedback from Microsoft, Salesforce etc., there's robust demand from industry. In an inflationary environment, businesses invest in software to reduce their cost of production. We may see some false bottoms this year. Now is the time to be conservative as an investor. Look at profitable companies or core geographies that are profitable, not making losses to prove that the tech works. It has discovered since 2000 that all tech isn't created equal as the underlying business model

and software varies. In the current downturn, will investors differentiate between computer games, enterprise software and telecoms companies? In 2000, they were all the same. It behoves the investors to truly understand what these companies do as the days where all tech companies were 10x revenues is gone. There could be a move to B2B and away from consumerfocused businesses, from growth to value, and from unprofitable to profitable companies. As inflation and interest rates pick up, remember that the big tech companies are largely unlevered, which is good news. They are the largest holders of cash outside sovereign funds on the planet. Growth funds and VC funds have also raised a lot of cash ahead of this downturn, and the best founders have raised precautionary rounds. Therefore, there is more cash around to invest in companies with loads of cash and no leverage, so you get better returns on your cash even as interest rates rise.

Novastar (top tier Africa-focused VC fund): It has been busy with both new and follow-on investment opportunities as its portfolio companies are venture assets, typically prioritising growth over profitability at this stage. With high profile international investors joining the mix last year, the deal velocity and valuations ramped up significantly, challenging companies to convert that fresh capital into value. Nowadays, the velocity of capital rounds is slowing a bit, even if there is sufficient capital for the best companies and Novastar is seeing evidence of pressure on valuations. Also, considering the upcoming election risks in Kenya and Nigeria, it's advising its portfolio companies to raise funds sooner to extend their runway to at least 18 months and reduce vulnerability. Another thing is that as companies move through stages of maturity, we should expect some bigger round deals to be announced. So, while the pace of fundraising may slow to last year's levels, the quality of decision making should improve. It is more concerned about extended shocks to purchasing power in markets such as Nigeria, or material negative headlines at large companies such as Flutterwave and sector implications.





battle headwinds so why are investors pricing the shares at such a discounted level to fair value?

Banks in Nigeria have been facing a number of headwinds which investors fear could dampen profits in coming years.

On the macro-side growth remains sluggish, inflation high, real per capita incomes falling, and unemployment elevated, while on the policy side regulatory uncertainty is beginning to creep in.

The Central Bank of Nigeria (CBN) set the minimum loan-to-deposit ratio (LDR) for banks at 60 percent in a bid to spur lending.

This means that for every N100 in deposits banks hold,

they must at least lend out N60 to retail clients and small businesses, instead of binging on 'risk free' Federal government securities

As a result, investors are fretting that profitability of the banks may take a hit in the short to medium term due to potential reduction in relatively easy to earn interest income from lending to the Federal Government, as opposed to the difficult (and inherently risky) business of granting consumer and other

forms of retail/SME credit. Another potential headwind for lenders in Nigeria is the licensing by the CBN of Telecommunication firms (MTN and Airtel) to operate Payment Service Banks (see

our front page), which could be a huge game changer for financial inclusion and of course banking as we know it.

The country's mobile operators; MTN, Airtel, Globacom and 9mobile recently announced their commitment to deepen financial inclusion to at least 90 million customers in about 2 years, once issued payment service banking (PSB) or mobile money licenses.

The four Telco's combined have some 199.5 million customers, compared to the 21 DMBs with about 30 million bank accounts with unique bank verification numbers (BVNs)

The Telco's also have the

resources to deploy in the coming fight.

MTN Nigeria recently announced its audited 2021 financial statement, reporting an impressive 23.3% growth in service revenue to N1.7trillion or \$3.98 billion, despite losing 8million or 10.5% of its mobile subscribers in the year, due to restriction on new SIM sales. MTN grew profit before tax to N298.7 billion or \$720 million, translating to 45.5% year-onvear growth and an expanded margin of 18.1%

No Deposit Money Bankin the country currently boasts such revenues.

There is also the issue of attractiveness of bonds relative to equities. With FGN bonds on average yielding around 12 percent per annum.

So are bank stocks currently a value trap?, defined as a stock that appears to be cheap because it has been trading at low valuation metrics such as multiples of earnings, cash flow or book value for an extended time period.

The trap springs however when investors buy into the company at low prices and the stock continues to languish or drop further.

We think the answer is that it is not quite so black and white. Huge opportunities abound in the banking space largely due to huge demographic gains to be had from a population expected to hit 350 million by 2050, cost savings from digital and technology innovations by banks, and the upside from being able to solve the financing needs of millions of Nigerians.

Lenders have no alternative to real banking as opposed to financial engineering, which should largely be left for investment banks and other players in the capital markets.

However there will be winners and losers, and investors will be well served by closely monitoring their holdings of bank stocks, trading around positions, and betting big on those names that are driving innovation in the space.


Wema Bank Nigeria Plc is firing on all cylinders as it is enjoying one of the best stock rallies since its existence, which validates a consistent earnings growth in the last three years.

The small and mid-sized lender surreptitiously leapfrogged over peer rivals on the same level to record the strongest return on equity.

In short, it recorded a return on equity (ROE) of 15.96 percent in the first quarter, which compares to Fidelity Bank's (13.29 percent); First City Monument Bank, (8.39 percent); Union Bank, (8.18 percent), and Sterling Bank (7.79 percent).

Because Wema Bank has been recording growth at the top line (gross earnings) and bottom line (profit), as its shareholders' funds moved to N71.57 billion in March 2022, from N48 billion in 2017; what this means is that it can effortlessly reward shareholders in the form of dividend payment.

The lender has a year to date return (which means its shares have been gaining since the start of the year) of



395.83 percent, which outperforms the NGX-ASI Index which is up 23.49 percent and NGX30 up 19.39 percent in the same period, according to data from the NGX.



International Breweries Plc has done well in managing cost of sales amid inflationary pressures, supply chain bottlenecks, foreign exchange scarcity, and decrepit infrastructure as the brewer recorded the fastest gross margin expansion among peer rivals.

The strong growth in gross margin was supported by the restoration of social activities as the brewer adjusted its sales and marketing strategies to suit the dynamics of the new normal.

Of course, the synchronised easing of the Covid-19 guidelines paves the way for beer drinkers to hit the bar, which has a positive effect on sales volumes.



International Breweries' gross profit margin expanded by 18.05 percent as at March 2022, according to MoneyCentral calculations.

That compares with Unilever's 9.57 percent; Cadbury, 8.58 percent; Nigerian Breweries, 7.79 percent; Guinness, 7.65 percent. However, the majority

of consumer goods firms capitulated to rising input costs as gross margins deteriorated.

Vitafoam recorded gross margin contraction of 2.25 percent; Nestle, 0.58 percent; HoneyWell Flour, 5.21 percent; 3.99 percent PZ Cussons, 4 percent; Champions, 34.15 percent; Dangote Sugar, 6.17 percent; Nascon, 15.26 percent, and BUA foods, 3.65 percent.

International Brewers, Guinness, and Nigerian Breweries, the three dominant brewers, outperformed peer rivals in the consumer goods industry.

The brewers benefitted from the injection of a N2.80 trillion stimulus in 2021, and the country's favorable demographic (+206.0 million population with 100 million within the beer consuming age) means Nigeria has an edge over other African countries

The National Bureau of Statistics has said that Nigerian residents spent N108.47 trillion on household consumption in 2021 in nominal terms.

The figure is higher than the N97.72 trillion recorded in 2020, showing an increase of 11 per cent amid doubledigit inflation.

On the global front, the pandemic stimulus checks paid to citizens by the United States and European government quantitative easing combined with the relaxation of social distancing boosted beer consumption.

Global wheat prices hit record high after Indian exports ban

Wheat prices surged to a new record high last week after India decided to prohibit exports of the commodity as a heatwave hit production. The price climbed to €435 (\$453) per ton as the European market opened.

Soft red winter wheat for July delivery rose 4.2%. New Delhi said last week it was curbing exports as the country, the world's second-largest wheat producer, saw its hottest March on record.

The authorities have expressed worries about the food security of the nation's own 1.4 billion people amid lower production and sharply higher global prices.

Export deals agreed before the directive issued on May 13 could still be honored but future shipments will need government approval, New Delhi said.

The export ban drew sharp




criticism from the Group of Seven industrialized nations, which said that such measures "would worsen the crisis" of rising food prices.

India, which possesses major buffer stocks, previously said it was ready to help compensate for some of the

supply shortages caused by the Russia-Ukraine conflict. The two countries are ma-

jor suppliers to the international market, accounting for around 30% of global wheat exports. The situation has raised fears that the world could be on the brink of a major food crisis.

Leadway Assurance Company Limited, the largest insurer by total asset in Africa's most populous nation, has reported a rise in premium written (GPW) for the year ended December 2021 to N70.62 billion, as rising bond yields bolstered underwriting results.

Leadway Assurance's premium written increased, yearon-year, by 31.14 percent from the N53.85 billion reported in FY-2020, driven by growth in all segments.

In life business, GPW was up 18.10 percent to N36.43 billion as at December 2020, while the non-life segment spiked by 47.90 percent to N34.18 billion.

The insurer notes that it continues to see strong market conditions and improvement in macro-economy, and it is optimistic that its innovative market penetrating products will continue to meet customers' needs.

Underwriting income was up 27.75 percent to N50.65 billion as at December 2021, thanks to improvement in the annuity market as a result of the lifting of lock down and general improvement in the economy after covid-19 pandemic.

Additionally, the uptick in underwriting income can be attributed to the improvement in non-specialty business arising from the change in attitude of people regarding insurance after the end Sars protest.

Leadway Assurance delivered positive underwriting results that were bolstered by rise in yield on bond securities over the year which resulted in a decrease in liabilities of its life business by N79.6 billion, specifically, in the annuity portfolio.

Financial institutions have been benefitting from the gradual increases in bond yields emblematic in a benign yield environment.

When yields are rising insurers make money by packing policyholders in insecurities to earn sizable income that helps compensate for deteriorating underwriting conditions brought on mounting claims. The 12-month treasury yield which hovered between 1 percent and 3 percent between the last quarter of 2020 and first quarter of 2021 (pre and post pandemic period) now stands at 4.90 percent.

Also, Nigeria's 10-year yield stood at 12.0 percent on Friday, May 20, according to over-thecounter interbank yield quotes for this government bond maturity.

And that compares with 8 percent in the first quarter of 2021 and 4.18 percent in the last quarter of 2020, according to data from Statista.

Interestingly, Leadway Assurance's combined ratio of 96 percent is below the 100 percent threshold, which means it is not paying out more money in claims than it is receiving in premiums.

Higher demand and investment returns, expansion in the credit quality of fixed income securities and reduced mortality rates due to roll out of vaccine, has added impetus to the earnings, reserves, and profitability of the composite insurer.

Pretax profit was up 4.73 percent to N11.95 billion in December 2021 from N11.41 billion the previous year.

The single digit growth at the bottom line (profit) was due to N83.68 billion fair value loss on assets at fair value.

The profits of the largest insurers were hard hit by fair value loss on assets as a lot of them had to book losses due to rising bond yields, and the good tiding is that such items are one off and do not occur at all times.

Leadway has maintained another year-on-year increase with N48 billion claims settlement, sustaining its five-year streak of outpacing the industry players in claims expense to policyholders.

Claims expenses were up 10 percent to N48 billion in 2021 from N43.50 billion as at December 2020.

"At the turn of the new decade last year, we reaffirmed our mission and mandate to deliver superior insurance services to individuals and corporations alike. That commitment has propelled us to maintain a yearon-year increase in our claims to our policyholders," said Tunde Hassan-Odukale, Managing Director/Chief Executive Officer, Leadway Assurance.

'This year, we paid the highest amount ever in the annals of the company and perhaps the largest in the insurance industry in 2021. Despite the prevailing economic realities and other adverse economic indices, we heralded this leadership position last year with an equally superior industry-leading payout," said Odukale.

Sunu Assurance returns to profit as expenses reduce

One of the fastest growing writing results. underwriting firms in Nigeria, Sunu Assurance Plc has returned to the path of profitability on the back of a sharp reduction in expenses even amid inflationary pressures and currency volatility.

The insurer posted a profit after tax of N153.03 million in the first quarter, from a loss of N174.68 million as at March 2021.

That represents its first profit since 2019, and a double digit growth in revenue buoyed by the introduction of innovative products helped boost under-

The improvement at the bottom was largely due to a reduction in expense ratio as the insurer spent less on expenses to generate premium income, thanks to cost control measures put in place by the management of the company.

Expense ratio reduced to 64.69 percent in 2022, from 65.62 percent in 2021, according to MoneyCentral calculations.

Further calculations by MoneyCentral shows the combined ratio improved to 94.19 percent in the period under review from 135.75 percent as at March 2021.

Of course, Sunu Assurance's underwriting profit surged by 165.26 percent to N637.51 million as at March 2022, from N240.33 million the previous year.

The combined ratio is typically expressed as a percentage. A ratio below 100 percent indicates that the company is making an underwriting profit, while a ratio above 100 percent means that it is paying out more money in claims that it is receiving from premiums. Even if the combined ratio is above 100 percent, a company can potentially still be profitable because the ratio does

not include investment income.

The insurer introduced innovative products that are increasingly making an inroad into the market, and these products are also boosted revenue

Gross Premium income was up 40.74 percent to N1.53 billion in the period under review from N1.08 billion the previous year.

Net premium income followed the same growth trajectory as it increased by 38.22 percent to N1.28 billion in the period under review from N926.70 million as at March 2021.

The company has honored obligations to policyholders as it paid out N378.72 million in claims, and that presents a 1.85 percent increase from 2021's N371.93 million.

However, it spent less on aims collections to generate revenue as claims ratio fell to 29.50 percent in the period under review from 40.14 percent the previous year.

To fund its expansion plans, Sunu Assurance did a private placement of N3.01 billion

Lagos explains okada clampdown

The Lagos State Government has described the ongoing enforcement of restrictions on the operations of commercial motorcycles, popularly called okada, in certain parts of the State as a necessary step to curb their indiscipline, save lives and improve security.

Commissioner for Information and Strategy, Gbenga Omotoso, spoke on Channels TV Sunrise Daily about the new enforcement order given by Governor Babajide Sanwo-Olu and the backlash recorded in a part of the State. According to Omotoso,

According to Omotoso, the resurgence of Okada operations and acts of indiscipline being exhibited by riders have become a serious source of concern as many people have lost their limbs and lives through Okada accidents.

His words: "Our doctors are



complaining that more and more people are coming with Okada-related emergencies. About 1,712 accidents have been recorded in Lagos in the first quarter of this year. Out of this figure, about 45 percent; to be precise, 767 of the accidents were caused by Okada. And it is shocking to know that about 54 percent of the victims are between the ages of 30 and 39. These are our able-bodied young people who are getting cut down like that all because they mounted okada."

Attributing the high fatality rate of riders and passengers to plying about 500 highways, major roads and bridges, which the Road Traffic Law prohibited, Omotoso affirmed that Governor Babajide Sanwo-Olu's order was to reinforce the law and give the riders an opportunity to move out and find some other things to do. He said: "There is a Law that lists all the routes commercial motorcycles are restricted from plying. The Law is still there; it has not been repealed. So, the enforcement is not new and it is going to continue as the June 1st deadline stands."

Describing as unfortunate the insecurity in some parts of the country that has forced many people to migrate to Lagos to make ends meet by riding Okada, the Commissioner explained that the development led to complaints from residents who have expressed their rejection of okada.

"Lagosians are worried about the mystery of Okada; they don't know where they come from; the riders are unknown; they don't even have number plates. They don't come for LASRRA registration, so we can't account for them," he said.

Ogun begins laying of 5,000 fibre optic cable to boost internet connectivity

The Ogun State Government has begun laying of 5000 kilometre fibre optic cable that would link the 20 local government areas of the state. The laying of the cable was

part of the three main areas in which the state was deploying resources for Information and Communication Technology (ICT) infrastructure.

The Special Assistant to the Ogun State Governor on ICT, Mr. Olakunle Akinbola, disclosed the efforts of the government at opening of a worship on ICT/E-Commerce Value Chain for stakeholders.

The workshop was sponsored by a German Development Agency, GIZ, organised in collaboration with the Bureau of Information. Technology (BIT), Ogun State, had stakeholders from Academia, Chambers of Commerce, business community, ICT companies and Government Agencies.

The workshop was organised under the heading, " Pro-Poor Growth and Promotion of Employment in Nigeria Programme- known as SEDIN."

Akinbola, who disclosed that the state had laid about 2000 kilometre optic cables, said the essence of the project was to make internet connectivity available to all local governments in the first instance.

He said: "The essence of the project is to have internet connectivity across the state.

"The idea is that as soon as we get into local governments, from each local government, we can now go into phase two of the project, which is to deliver the fibre connectivity to schools and hospitals so that those establishments can enjoy internet connectivity.

Ekiti Government debunks spending millions on private jets for campaign travels

The attention of the Governor of Ekiti State, Dr Kayode Fayemi, has been drawn to a news report in Newspapers on May 20, 2022, where the Governor was alleged to have squandered millions of state funds on chartered flight in the course of his recent political activities.

The unduly generalised report, titled: "Wike, Fayemi, Tambuwal, six other governors squander millions on private jets," is not only inaccurate and misleading, it is bereft of facts, which made it fall short of the journalistic standard," according to a statement by Yinka Oyebode Chief Press Secretary to the Governor, Ekiti State.

"One wonders how the newspaper arrived at the number of chartered flights the Governor has taken in the course of his recent political activities, which it put at 16. We also consider it poor journalistic work for the newspaper to assume that all the trips to the states mentioned in the report were via private jets." "For the avoidance of

doubt, while it is correct that Governor Fayemi occasionally uses private jets to get to some difficult to reach places and when commercial flights disappoint, alternative arrangements are made for such trips, more often than not, supported by friends.

"It must be stated that Governor Fayemi does not use state resources for his personal or political trips, as these are distinct from official trips.

"While we do not dispute the role of the media to inform the public, we are of the opinion that such should be done with due regard for fairness and accuracy of information."

Oyebode then challenged the newspaper to provide evidence that Ekiti State funds were used for private jets, otherwise he demanded that the report be retracted.

Ondo assembly passes 2022 OSOPADEC budget into law

Ondo State House of Assembly on Thursday passed into law the 2022 estimate of the Ondo State Oil Producing Areas Development Commission (OSOPADEC) put at N11.4 billion.

This followed the submission and consideration of the joint report of the House Committees on Finance and Appropriation as well as OSOPADEC at plenary.

The Chairman, House Committee on Finance and Appropriation, Mr Sunday Olajide explained that the proposal for personnel cost was increased from N1.3 billion to N1.5 billion, while project development rose from N5 billion to N6 billion.

He recommended that all ongoing projects should get the needed attention with a view to ensuring their quick completion. The Majority Leader, Olu-

wole Ogunmolasuyi moved

the motion for the bill to be passed into law and it was seconded by the Deputy Speaker, Mr Samuel Aderoboye.

The Speaker, Mr Bamidele Oleyelogun ruled for the bill to be passed into law after the lawmakers gave their nods through voice vote.

Oleyelogun charged OSO-PADEC to ensure proper distribution of funds in the estimate for the benefit of the people in the mandate area.

Also the house cleared outstanding issues and queries raised in the 2015 to 2018 report of the state Auditor-General after the submission and consideration of reports of the House Committee on Public Account.

UEFA dumps proposed €6bn Covid- 19 relief package for European clubs

European football governing body UEFA is reportedly shelving plans for a $\notin 6$ billion financial package to help European football recover from the effects of the Covid-19 pandemic.

Bloomberg reports that the UEFA will not proceed with the €6 billion rescue package arranged with US Bank Citigroup. UEFA's plans have been complicated by how the fund would fit within the governing body's financial structure, particularly around the distribution to the clubs.

In the summer of 2021, UEFA proposed giving cash-strapped teams access to their future earnings from club competitions like the Champions League.

However, the plans seem to have foundered on the potential conflicts between UEFA both overseeing/regulating the financial viability of clubs and providing them with

money. However, UEFA has not entirely discarded the idea and is weighing its options for the future, including a joint venture with other bodies.

In 2020, FIFA approved a \$1.5 billion Covid-19 relief fund for world football. Member associations were eligible to apply for two tranches of \$500,000 as well as \$500,000 for the women's game. Federations were also entitled to a minimum loan of \$500,000 and a maximum loan of \$5 million. In addition, each confederation could access a loan of up to \$4 million.

Amnesty orders FIFA to pay \$440m compensation to Qatar migrant workers

Amnesty International, Football Supporters Europe and eight other human rights groups have urged FIFA to pay the sum of \$440 million as compensation for hundreds of thousands of abused Qatar migrant workers.

The call follows allegations that FIFA was slow to safeguard against the exploitation of workers who flooded into the tiny Gulf state to work on World Cup infrastructure.

In an open letter sent to FIFA President Gianni Infantino, the coalition of 10 groups say FIFA should work with Qatar to "establish a comprehensive programme to ensure all labour abuses to which FIFA contributed are remedied."

"With six months until the opening of the FIFA World Cup Qatar 2022, hundreds of thousands of migrant workers have not received adequate remedy, including financial compensation, for serious labour abuses they suffered while building and servicing infrastructure essential for the preparation and delivery of the World Cup in Qatar."

"FIFA should reserve an amount not less than the US\$440 million prize money offered to teams participating in the World Cup, to be invested in funds to support remediation."

The letter claims Qatari authorities have "failed to investigate the causes of deaths of thousands of migrant workers since 2010", the year the tournament was awarded to the country.

The 10 signatories are Amnesty International, Human Rights Watch, FairSquare, The Army of Survivors, Building and Wood Workers' International (BWI), Business & Human Rights Resource Centre (BHRRC), Equidem, Football Supporters Europe (FSE), Independent Supporters Council North America (ISC) and

Migrant-Rights.org.

While recognising the significant progress made to protect workers' rights in the country, the letter, written by Amnesty general secretary Agnès Callamard, states FIFA and Qatar "can and should act to provide redress and prevent further abuses from taking place."

Foreign workers, mainly from South Asia, make up more than two million of Qatar's 2.8 million population and the letter adds: "Given the history of human rights abuses in the country, FIFA knew – or should have known – the obvious risks to workers when it awarded the tournament to Qatar.

"Despite this, there was not a single mention of workers or human rights in its evaluation of the Qatari bid and no conditions were put in place on labour protections. FIFA has since done far too little to prevent or mitigate those risks.

"By turning a blind eye to foreseeable human rights abuses and failing to stop them, FIFA indisputably contributed to the widespread abuse of migrant workers involved in World Cup-related projects in Qatar, far beyond the stadiums and official hotels."

"Providing compensation to workers who gave so much to make the tournament happen, and taking steps to make sure such abuses never happen again, could represent a major turning point in FIFA's commitment to respect human rights."

In response FIFA was quoted as saying that it was working with Qatar's World Cup organisers, known as the Supreme Committee for Delivery and Legacy, to "implement an unprecedented due diligence process" concerning protecting workers' rights.

Tier 1 Banks' income from T-bills hit N233.15 bn in Q1


The top 5 largest banks in Africa's largest economy are gradually enjoying juicy yields as income from treasury bills, government bonds and others grew at the fastest pace in a decade.

It is noteworthy that lenders pack their money in fixed income securities when yields are high to earn sizable income, which means central bank's monetary policies are pivotal to sector players' earnings growth.

For instance, Zenith Bank, Access Bank, United Bank for Africa, Guaranty Trust Holdings Company, and FirstBank Holdings saw their combined income from investment securities jump 33.63 percent to N233.92 billion as at March 2021, according to data gathered by MonevCentral.

In the 2020 financial year, income from both short and long term government securities jumped 7.03 percent to N175.04 billion.

Tier 1 lenders witnessed a drop of 18.20 percent in income from short and long term government securities to N163.55 billion, as the decision of the central bank to ban individuals and local corporates from investing in its OMO bills sent T-bills yields crashing.



In the last six years, these five lenders made N1.01 trillion in income from investment securities, and analysts are optimistic they will continue to enjoy juicy yields on the expectation of a benign interest rate environment.

The 12-month treasury yield which hovered between 1 percent and 3 percent between the last quarter of 2020 and first quarter of 2021 (pre and post pandemic period) now stands at 4.90 percent.

Also, Nigeria's 10-year yield stood at 12.0 percent on Monday, May 16, according to over-the-counter interbank yield quotes for this government bond maturity.

And that compares with 8 percent in the first quarter of 2021 and 4.18 percent in the last quarter of 2020, according to data from Statista.

Zenith Bank realised N71.07 billion in short and long term government securities, which is 52.30 percent higher than 2021's N46.66 billion. It raked in N304.66 billion in the last six years.

Access Bank, the largest lender by total assets, saw income from investment securities spike by N67.97 billion in the first quarter of 2022 and it made N192.41 billion in the last six years.

United Bank for Africa (UBA) saw income from treasury bills and bonds increase by 30.75 percent to N49.30 billion as at March 2022.

Guaranty Trust Holdings Company or GTCO's income from investment securities were up 22.74 percent to N11.82 billion in March 2022 from N9.63 billion the previous year.

Of course, risky assets are beaten down due to selloff of shares as investors are most likely to move their money to save haven assets.

Company balance sheets are healthy as executives took advantage of cheap debt to refinance during the Covid-19 crisis, which puts them in an advantageous position to weather rising interest rates.

Total debts (long and short term) in the balance sheet of the largest quoted firms stood at N1.86 trillion as at March 2022, and that is 6.81 percent higher than 2021's N1.74 trillion, according to data gathered by MoneyCentral.

MTNNigeria Communications (MTNN) Plc, Dangote Cement Plc and 14 others raised N339.46 billion on commercial papers (CPs) in 2021. Commercial papers are short-term debt securities typi-

THE BOTTOM LINE 5 reasons why talk of Dangote being broke is financial illiteracy

Recently there have been publications in some online media to the effect that Africa's richest man Aliko Dangote is broke, with his holding Company Dangote Industries Limited (DIL) said to be unable to complete its multi-billion dollars 650,000-barrel refinery in the outskirts of Lagos.

We believe such reports to be financial illiteracy and a lack of understanding of how modern finance works.

A simple definition of financial illiteracy is the opposite of financial literacy. Financial literacy is the knowledge necessary to make important financial decisions. It can help with decisions about budgets, debt, and investing.

Dangote is the 66th richest man in the world, and worth \$21 billion, according to the Bloomberg Billionaires Index.

MoneyCentral will below breakdown the reasons Dangote cannot be 'broke' and how the current and future cash flows from all of his productive assets (sugar, cement, refining, salt, agriculture, fertilizer etc) are the source of his wealth.

DIL is a diversified conglomerate in Nigeria with a leading share in the cement business and a future key operator in the petrochemical industry through its fertiliser and oil refinery business.

Its strategy is to gradually establish a downstream industry in Nigeria and be the largest urea producer in Nigeria. It also aims to make Nigeria a net exporter of refined petroleum products and petrochemicals by 2026.

Dangote Cement shares is as good as currency...stupid!

Dangote Cement Plc (DCP), the flagship company of DIL, is a significant contributo consolidated profile.

The company is supported by large-scale operations in Nigeria and Pan-Africa. In 2021, DCP's earnings before interest, taxes, depreciation, and amortization or EBITDA contribution to DIL stood above 90%.

In 2021, revenues from cement sales in all its operations

(Nigeria and the rest of Africa) rose by 34% and amounted to N1.383 trillion. After paying taxes and making other expenses Dangote Cement reported profit of N346.4 billion.

Fitch Ratings forecasts that Dangote's cement business will average \$1.1 billion per annum in EBITDA between 2022 and 2025, making it one of the most profitable cement firms in the world.

DIL owns 85.8% of Dangote Cement.

Because of the expected free cash flows from the cement operations, Dangote cement stock which are listed on the Nigeria Exchange Limited, are valued at 14 times earnings, for a market capitalization of N5.11 trillion.

This means that from just one of his firms, Dangote Cement alone, Aliko Dangote is liquid to the tune of N4.38 trillion (representing DIL's 85.8% ownership).

A liquid asset is an asset that can easily be converted into cash in a short amount of time. Stocks,

money market instruments and marketable securities are generally considered liquid assets.

This alone debunks the notion of Dangote being broke as he can sell down his stake in the cement firm or borrow against its assets if he chooses, as a way to raise money.

Dangote Cement also pays a healthy dividend.

In 2021 the Directors recommended a dividend of N20 per share for shareholders. Money-Central calculates that DIL received N292 billion as dividends last year from Dangote Cement.

Fitch estimates that DIL's refinery project is still on track to be completed by 2023, and requires additional \$1.1 billion (N462 billion) of capex in 2022. Equity sale in refinery

The Nigerian National Petroleum Corporation (NNPC) in 2021 took a 20% stake worth \$2.76 billion in the Dangote refinery Project valuing the refinery at \$13.8 billion then. We believe the valuation is much higher today with the refinery nearing completion and current geopolitical landscape with the Russia - Ukraine war, which has sent commodities soaring.

Funding for the completion of the refinery project could then be gotten through further asset sales in the project.

DIL could today probably raise \$2 billion with a 10% - 15% sale of stake in the refinery, more than is needed to complete the project.

MoneyCentral however believes this is unlikely as the refinery project is a future cash cow for DIL. Once operational, Fitch expects the project to contribute around \$1 billion to EBITDA annually when ramped up from 2024.

Assets for loan

One way through which companies finance expansions or acquisitions is through loans backed by their existing assets. Dangote Industries Limited

(DIL) is planning to establish a

local bond programme amounting to \$750 million to partially finance the completion of its refinery and petrochemical plant.

Monday 23rd - 29th May 2022

Dangote Oil Refining Company Limited (DORC) and Dangote Fertiliser Limited (DFL), DIL's subsidiaries, will be co-obligors under the proposed programme.

The bond programme, together with DILs retained earnings from its other operations should be enough cash to complete the refinery in MoneyCentral's opinion.

Fertilizer

Dangote's fertilizer plant was commissioned last year and there were 2 lines operational as of April 2022.

The fertilizer plant line 1 is expected to gradually ramp up to an average 60% capacity utilisation in 2022-2023 and to around 80% by 2025, from 25% in 2021. Line 2 will ramp to around 80% capacity rate by 2025 from 50% in 2022, according to Fitch.

The fertilizer plant is expected to be highly profitable also with 66% EBITDA margin in 2022-2025.

Prices of urea have soared as the Russia - Ukraine war affected commodity prices. urea FOB US Gulf for May delivery traded at USD630/ton yesterday (May 17).

Dangote Fertilizer plant has also begun exports of its product meaning it is earning foreign exchange for DIL, which can be channeled into the completion of the refinery project.

DIL Liquidity

Fitch estimates DIL to have an adequate liquidity score at 1.5x for 2021 with estimated total external group debt of \$3.8 billion.

It has no significant maturities until 2023 when Fitch expects the refinery to start generating cash flow.

"We expect positive free cash flow FCF from 2023 when both projects (refinery and fertilizer plants) are ramped up and capex is moderate," Fitch said.

In essence Aliko Dangote is far from broke and will continue to smile all the way to the bank as all his major projects : cement, refinery and fertilizer generate mountains of cash annually into the foreseeable future.
