

Nigerian firms dash for cash in liquidity push ahead of elections

Nigerian companies are increasingly maxing out credit lines and resorting to commercial paper and bond issuances, as they seek to grab cash amid an uncertain 2023 electoral cycle, rising bond yields and an economy still growing below

"A lot of firms tap into shortterm finance to continue the purchase of raw materials. It is a hedging strategy to edge against supply chain disruption and foreign exchange risk," said Gbolahan Ologunro, equity research analyst at Cordros Securities.

'We will have a liquidity crisis if they are not able to convert those raw materials into finished products," said Ologunro.

Commercial paper issuances hit N487.0 billion in half-year (H1) 2022, and that is 30.11 percent higher than 2021's N374.30 billion at an average rate of 11.30 percent, according to data gathered by Afrinvest Securities.

The average cash ratio of the largest companies stood at 0.43 percent in June 2022 from 0.44 percent, according to data gathered by MoneyCentral.

The cash ratio is a liquidity

measure that shows a company's ability to cover its short-term obligations using only cash and cash equivalents. The ratio

Lagos home to 6,300 millionaires, 4th highest in Africa

A new Henley Global Citizens report reveals that 6,300 millionaires and 3 billionaires live in Lagos, Nigeria, ranking it the fourth highest among African

The new report published Tuesday by Henley Global Citi-

zens reveals that of the 6,300 millionaires that live in Lagos, 330 have a fortune of more than \$10 million, 20 residents have a fortune worth more than \$100 million - and there are 3 billionaires.

Lagos which is Nigeria's larg est city and commercial capital is placed fourth in the list of the five richest cities in Africa according to the number of millionaires who live there.

The top five are Johannesburg, Cairo, Cape Town, Lagos and Nairobi.

ANAP poll flawed by lack of assigned weightings to regions

...huge undecided in PDP/APC strongholds

A new poll commissioned by the Anap Foundation and conducted by NOI Polls Limited, showing the candidate of the Labour Party, Mr Peter Obi leading in the race for the 2023 Presidential election is flawed due to the huge number of undecided voters as well as a lack of weighting assigned to different regions, according to MoneyCentral analysis.

The poll results released by ANAP showed that the total percentage of those who are undecided or refused to participate was 47%, which is more than double the score for the winner of the poll Obi who got 21%.

This makes it statistically impossible to infer anything meaningful from the results.

When the All Progressives Congress (APC) candidate, Mr Bola Tinubu's score of 13%; and People's Democratic Party (PDP) candidate, Atiku Abubakar's score of 13% is added to Obi's score, it comes to 47%.

It means all three candi-

dates combined are below the 50% mark while the undecided votes are statistically too large (equal to all three), to make the results anything but noise at this

Compounding the problem is the fact that those who are undecided or refused to participate in the polls come mainly from the APC and PDP strongholds of the South West (SW), North West (NW) and North East (NE).

For instance, the percentage of those refusing to participate or were undecided was 51% in the NE, 45% in the NW and as high as 60% in the SW. It was only 30% in the South East (SE).

Again this had the impact of skewing the poll results.

Another major issue is that there is no weighting given to regions. Historical 2019 actual voting data reviewed by MoneyCentral shows voting populations differ from region to region.

For instance, in 2019

while South East total votes cast was 2.1 million in the North West 8.29 million votes were cast (for the top 5 candidates).

In other words, the NW weighting should be at least 3 to 4 times what was given to SE. Or put differently 3 to 4 actual people living in the NW should have been polled for every 1 person from the SE and this should have been reflected in the results released by ANAP/NOI Polls.

There is however no evidence that this was done as part of the methodology.

In the USA for instance, polling is done with particular weighing given to democrats or republicans in the sample size which roughly corresponds to voter registrations in a particular city or state.

MoneyCentral believes that the ANAP/NOI polls can capture an accurate snapshot of the state of the 2023 Presidential race if the highlighted shortcomings are corrected in subsequent

Nigeria's NIN enrolment nears 90 million, says NIMC

Almost 90 million people have registered for the National Identification Number (NIN), the National Identity Management Commission (NIMC) has said.

NIMC Director-General and Chief Executive Officer, Aliyu Aziz, disclosed this on Friday in Abuja at an event to commemorate the fourth National Identity Day with the theme 'Traditional Institution as Critical Stakeholders for Citizens Mobilisation.

'Without sounding immodest, NIMC has made great strides on so many fronts in the last three years," he said. "From just over 1,000 enrolment centres and 2,000 enrolment devices across the country, NIMC in partnership with its licensed enrolment partners now has over 15,000 enrolment centres and over

29,000 enrolment devices deployed nationwide.

"This is one of the reasons enrolments have increased tremendously with over 89 million NINs generated successfully. On the international level, NIMC today has diaspora enrolment centres in over 40 countries, with more centres and countries scheduled to be added in the coming months."

With the development, Aziz explained, Nigerians in the diaspora would have the opportunity to enrol and have their national identity even while outside the shores of the country.

According to him, the more the government knows the accurate number of its population and the right demographics, the better it is placed to plan well for infrastructure, social welfare, and economic development.


Kidney donation to ailing Sonia Ekweremadu: Kaduna based journalist joins 2 others

Nigeria's inflation rate rises to 20.52% in August – NBS

The National Bureau of Statistics (NBS) on Thursday said Nigeria's inflation rate rose to 20.52 per cent in August 2022.

In its report titled, 'CPI and Inflation Report August 2022, the Bureau stated, "In August 2022, on a year-on-year basis, the headline inflation rate

was 20.52%.

"This was 3.52% points higher compared to the rate recorded in August 2021, which was (17.01%). This shows that the headline inflation rate increased in the month of August 2022 when compared to the same month in the preceding year (i.e. August 2021)."

ASUU: Buhari meets with Pro-Chancellors of Universities, promises further consultations

President Muhammadu Buhari Friday at State House, Abuja, met with the Chairman and select members of Pro-Chancellors of Federal Universities, promising to engage in further consultations with relevant stakeholders, towards ending the protracted strike by university lecturers, under the aegis of Academic Staff Union of Universities (ASUU)

The president said without necessarily going back on what is already established policy, "I will make further consultations, and I'll get back to you."

The Pro-Chancellors who were led to the meeting by Professor Nimi Briggs, said they had come to meet with the President in three capacities: "As President and Commander-in-Chief, as father of the nation, and as Visitor to the Federal universities."

Professor Briggs added that despite the pall cast by more than seven months of industrial action, "the future of the university system in the country is good," citing as example the recent listing of the University of Ibadan among the first 1,000 universities in the



world, a development occurring for the first time.

He commended the Federal Government for concessions already made to the striking lecturers, including the offer to raise salaries by 23.5% across board, and 35% for Professors. He, however, asked for "further inching up of the salary, in view of the economic situation of the country."

The Pro-Chancellors also asked for a reconsideration of the No-Work, No-Pay stance of government, promising that lecturers would make up for time lost as soon as an amicable situation was reached, and schools reopened.

Minister of State for Education, Goodluck Nana Opiah, said all the concessions made by the Federal Government were to ensure that the industrial action comes to an end, but ASUU has remained adamant.

2023: PDP appoints Emmanuel, Tambuwal to lead presidential campaign

Akwa Ibom State Governor, Udom Emmanuel and Sokoto State Governor, Aminu Tambuwal

The Peoples Democratic Party has appointed Akwa Ibom State Governor Udom Emmanuel as the Chairman of its Presidential Campaign Council (PCC), while Sokoto State Governor Amina Tambuwal was named Director-General of the party's National Campaign Management Committee (NCMC).

Both men will be leading a campaign aimed at getting tne former ruling party back to power after eight years and helping former Vice President Atiku Abubakar realise his ambition of becoming President of Nigeria.

The appointments were contained in a release signed by the party's National Organising Secretary, Umar Bature, on Thursday.

Governor Emmanuel, who is chairing the Presidential Campaign Council, will be supported by two other governors.

Bauchi State Governor



Bala Mohammed was named Vice-Chairman of the Council (North), with Oyo State Governor Seyi Makinde chosen as Vice-Chairman

In all, the Presidential Campaign Council is composed of 326 people includdate Atiku Abubakar, his running mate Governor Ifeanyi Okowa, the National Chairman, Iyorchia Ayu, and the officials mentioned above.

The party's Board of Trustee Chairman, Senator Adolphus Wabba, former Vice President Namadi Sambo, and the party's governors including Governor Nyesom Wike of Rivers State were all named members of the council. They are part of 314 people designated as members of the council.

Banks enjoy juicy yields as income from T-bills hit N416.66 bn

It appears the central bank's hawkish tone this year is a boon for lenders who are enjoying juicy yields that adds impetus to the bottom line (profit) even amid regulatory headwinds and sluggish economic recovery.


The largest and most liquid banks collectively generated N416.66 billion in June 2022, the highest in close to a decade, according to data gathered by MoneyCentral.

The current figure (half-year 2022) is higher than the N356.71 billion raked in 2017 when yields were at an all-time high of between 22-18 percent.

Banks ingeniously pack their money in fixed income securities when interest rates are rising as they earn sizable returns that strengthen profitability and the return on equity.

Of course interest rates have been rising on the back of a shift from accommodative policy to hawkish tone by the regulator who seeks to tame red-hot inflation in the face of global political tensions.

The Monetary Policy Committee of the Central Bank of Nigeria has increased the benchmark interest rate (monetary



policy rate) from 13% to 14%.

Nigeria's headline inflation climbed to a new high of 20.52 per cent in August on a year-on-year basis, according to data from the National Bureau of Statistics (NBS).

The Nigeria 10Y Government Bond has a 12.811% yield, according to data from Government Bonds.

It is positive for banks in view of the challenges that they have

faced in recent times, said Gbolahan Ologuro, equity research at Cordros Securities.

"Now we are seeing soft growth in profitability that what we have seen in the past few years," said Ologunro.

The industry return on average equity (ROE) of the most liquid and capitalised lenders rose to 13.71 percent in June 2022 from 11.26 percent as at June 2021, according to Mon-

eyCentral calculations. That is higher than the 13.69 percent figure in 2020.

Their combined net income reached N496.47 billion, which is 18.42 percent from 2021's N419.22 billion the previous year.

A higher yield has also helped banks reprise their loan books in line with the prevailing yields environment, but loans have been stagnant due to the current macroeconomic conditions.

Banks realised a combined N1.19 trillion in interest on loans and advances from customers, which is 26.73 percent higher than 2021's N939.10 billion, according to data gathered by MoneyCentral.

Analysts say investors should add banks' stock to their portfolio because rising interest rates amid spiraling inflation will continue to lift earnings till next year.

Modular floating dockyard - Sambo charges NIMASA to deploy

The Honorable Minister of Transportation, Mr. Mu'azuJaji Sambo has charged the Management of the Nigerian Maritime Administration and Safety Agency, NIMASA, to ensure prompt deployment of the Modular Floating Dockyard the Agency acquired some time ago.

The Agency's Director General, Dr. Bashir Jamoh, who disclosed this while speaking with the media in Lagos, said that the Honorable Minister described the deployment of the Modular Dockyard as one of the low hanging fruits he hopes would be delivered to the nation within the part few months.

"When we met with the Honorable Minister last month, he made it clear that we need to deploy the Modular Floating Dockyard for the benefit of Nigerians. The truth is that we are working round the clock daily to ensure the Dockyard is put to use. We are working closely with the Nigerian Ports Authority, NPA, using lessons from past mistakes, to ensure a productive and sustainable deployment of the Modular Dockyard."

Dr. Jamoh said that both NI-MASA and NPA are set to complete the operationalization of the NIMASA Modular Floating Dockyard with the installation of dolphins and repair of facilities at the NPA Continental Shipyard facility, where the floating dock would be operated from.

He noted that NIMASA has completed the ongoing discussions with its co-partner, NPA



and other managing partners to provide the Continental Shipyard for the anchoring of the Dockyard. The Infrastructure Concession Regulatory Commission, ICRC, is closely providing guidance for the deployment

of the national asset on a Public Private Partnership PPP model, adding that the floating dock needs to go through an installation process before it starts functioning or be put to use

Leveraging agrotech to crash soaring food prices

Nigeria needs agriculture to feed its population and earn foreign exchange. But it is difficult to achieve with the traditional farming methods; hence, the need to leverage agrotech, writes **ONYEKORMAKA ASABOR**

From Statista's compilation of food prices in Nigeria in April 2022 (compared to the previous year), using 13 food items as case study, price of eggs went up by about 30 per cent, brown beans rose by 40 per cent and white black-eyed beans rose by 45 per cent.

Statista, an online portal that provides data on the global digital economy, industrial sector, consumer market, public opinion, media and macroeconomic trends, says one kilogramme of beef bone rose by 31.67 per cent, while that of boneless beef rose by 35.31 per cent. The price of bread (500g) rose by 34.65 per cent. One kilogramme of Ofada rice went up by 8.75 per cent, one kilogramme of fresh catfish rose by 25.65 per cent, dried one went up by 22 per cent, while smoked catfish was up by 13.75 per cent. Chicken laps increased by 18.93 per cent.

NBS data

The foregoing market survey carried out since April has gained momentum without allowing consumers a breathing space, as it has compelled them to groan under the weighty market situation, so much that the National Bureau of Statistics recently reported that the country's inflation rate jumped to nearly 20 per cent in July – the highest in nearly two decades.

NBS says price increases were recorded in necessities, forcing consumers to groan under the July inflation that was calculated to be 19.64 per cent – the highest since September 2005. The bureau found that the highest increases were recorded in necessities like food, clothing, accommodation, fuel and transportation.

Food prices, the NBS reported, have risen steadily in Nigeria for years, due to the effect of climate change, the Coronavirus Disease and widespread insecurity. In a similar vein, in February, when Russia invaded Ukraine, commodity prices soared, affecting the ability of millions of citizens to meet their basic needs.

From hand to mouth

That many salary earners now live from hand to mouth is just stating the obvious. A resident of Agege, Lagos State, Joshua Adenekan, whose monthly pay reportedly hovers between N95,000 and N100,000 depending on the deduction in a given month, said his salary could no longer cushion the impact of economic pressures.

He said, "Bills that I pay at the end of the month have increasingly been mounting due to soaring prices of goods and services. I cannot even talk of going to the market to buy something to feed myself because the prices are not encouraging at all. A loaf of bread that used to be N350 is now close to N1,000. Even some of the bakers in Lagos and Abuja have shut down their bakeries

due to the unprecedented high prices of production."

Enter the CBN

To address the rising inflation, the Central Bank of Nigeria has been strict with monetary policies. It increased interest rate from 11 per cent in January to 14 per cent in July 2022.

Experts were unanimous in the view that there is too much money in circulation chasing a few goods, thus causing inflation. According to them, there is scarcity in supply; hence, the CBN is using the Open Market Operation to reduce the money in circulation. With higher interest rate, people will be encouraged to save in the bank, leading to mop up of liquidity from the economy.

On his part, Jose Olorunyomi said Nigeria, being an import-dependent economy, has further been hit by currency devaluation. This is as the naira has lost more than 30 per cent of its value in eight months. Though he opined that inflation nowadays is a global problem, not peculiar to Nigeria.

He said, "It is not only Nigeria as a country that is passing through this inflationary phase. Even the United States' inflation is also soaring. Our neighbours, such as Ghana, are already experiencing inflationary rate of over 30 per cent."

Against the foregoing, it would be recalled that last March, the

World Bank estimated that four out of 10 Nigerians live below the national poverty line, while experts predict that inflation rate will increase further in coming months and send many more Nigerians into poverty. Going by the spiralling inflation being witnessed by consumers across the country, the prediction can be said to have come to pass.

As mentioned in one of its reports entitled 'Nigeria at a Glance, the Food and Agriculture Organisation of the United Nations stated, "Despite the contribution to the economy, Nigeria's agriculture sector faces many challenges, which impact its productivity. These include, poor land tenure system, low level of irrigation farming, climate change and land degradation. Others are low technology, high production cost and distribution of inputs, limited financing, high post-harvest losses and poor access to markets."

Agrotech to the rescue

At this juncture, it is expedient to say that of all the factors militating against bounty production of food in Nigeria, low technology stands as the weightiest of all, as the adoption of agricultural technology or agrotechnology, abbreviated as agrotech, by farmers is capable of rendering other factors inconsequential, if pragmatically adopted and implemented across board.

According to Cletus Iweka, the adoption of agrotech, as

done in developed economies, will lead to bounty production, which will eventually crash the prices of food items.

To many that understand basic economics, it is common knowledge that achieving bumper harvest following a promising farming season could lead to better agricultural yield, boost availability and, going by the economies of scale as well as forces of demand and supply, crash prices of food items.

Without recourse to explanation in this context, the law of demand and supply is an economic theory that explains how supply and demand are related to each other and how the relationship affects the price of goods and services. It is a fundamental economic principle that when supply exceeds demand for goods or services, prices fall; but when demand exceeds supply, prices tend to rise.

Gabriel Imudia, a consumer protection advocate, says when adoption of agrotech leads to increased or bumper production of agro products, there is the tendency for the prices of food items to crash.

In staggered chats on how the prices of various food items can be crashed, Financial Street gathered from respondents that the adoption of agrotech, which is the use of technology in agriculture, horticulture and aquaculture to improve yield efficiency and profitability, remains the solution.



Nigerian banks are spending heavily on improving technology to become more efficient amid pressure to get ahead of digital platforms who have created intense competition.

IT costs have been rising steadily over the past six years, and some of the lenders deepest pockets-First-Bank Holdings, Zenith Bank, Guaranty Trust Holding Company (GTCO), United Bank for Africa (UBA), and Access Bank- are spending less close to 5 percent of their annual revenue on technology.

Data gathered by MoneyCentral shows the largest lenders in



GTCO reins in costs as returns jump

Guaranty Trust Holding Company (GTCO) plc has been able to deliver higher returns to shareholders as it rein in on operating cost even amid regulatory charges, spiraling inflation, and foreign exchange volatility.

Return on average equity (ROAE), a key measure of profitability, increased to 23.89 percent in June 2022 from 19.71 percent the previous year. According to MoneyCentral calculations.

An efficient cost management gives a glimmer of hope that the lender will continue to record strong profit growth needed to bolster capital levels and strengthen investors' confidence.

A cursory look at



the financial statement shows operating expenses (OPEX) grew by 11.3 percent to N99.50 billion in June 2022 from N89.3 billion the previous year.

OPEX growth of 11.33 percent was below headline inflation which closed at 18.6% in June 2022. Operating cost was significantly impacted by increased Regulatory Costs - 20.4 percent growth in Deposit Insurance Premium and 6.39% growth in AMCON Expenses.

Banks in Africa's largest economy are reeling from rising operating costs that are brought on by regulatory costs such as the Asset Management Corporation Charge (AMCON) charge and inflationary pressures. GTCO saw pre-tax profit increase by 11 percent to N103.24 billion in the period under review from

N93.05 billion the previ-

ous year.

Net interest income was up 12.88 percent to N120.84 billion for the quarter ended June 30, 2022.

Nigeria pension industry lags global peers in penetration despite AUM growth

Despite the healthy Asset under Management (AUM) growth over the years, Nigeria's pension industry has a low penetration (GDP/AUM) relative to peers across the world, according to research house Chapel Hill Denham Limited.

Africa' largest economy that has adopted the contributory pension scheme in 2004 has a penetration of 7.60 percent, which is substantially lower than the European Union, (22 percent); Europe, 41 percent, and G7, 72 percent.

Nigeria's penetration is also below African peers such as Kenya 12.9 percent; and, South Africa, 10 percent, and Uganda 12.4 percent, albeit ahead of Ghana 6.30 percent.

Analysts at Chapel Hill Denham estimate that to scale up to Kenya's penetration over the next five years, Nigeria has to grow AUM at a CAGR of 29 percent to N50.77 trillion (\$80.36bn) by 2027 from N14.19tn (\$34.57 billion) as at 30 June 2022.

"A more compelling penetration of 40 percent over the next

10 years, close to Europe's penetration, requires Nigeria's AUM to grow at a CAGR of 33 percent between 2022 and 2032, faster than the 10-year CAGR of 19 percent between 2011 and 2021," said analysts at Chapel Hill

"This signals strong growth opportunities over the long term," said the analysts.

Experts are of the view that the effective implementation of the new Micro-Pension Scheme will help unlock the opportunities in the industry.

Ayodele Akinwunmi, an analyst at FSDH Merchant Bank noted that micro-pension will help to achieve the pension industry's strategic objective of covering 30 percent of the working population in Nigeria under the Contributory Pension Scheme (CPS) by the end of 2024.

"The traditional 'Pay as You Go' pension programme, mainly for workers in government and private establishments, does not capture the larger populace," said Akinwumi.

"The micro-pension scheme takes into account the peculiarity of the nature of business for the self-employed and non-salaried workers (farmers, artisans, vendors, domestic help and workers in MSMEs), hence contributions may be made daily, weekly, monthly or as may be convenient provided that contributions are made in any given year," adds Akinwumi.

Over the past 7 years, the Pension Industry has been growing steadily, thanks to a growing young population, greater al-

location of pension assets to equity and real estate, and the successful implementation of the PRA Act of 2014.

The industry AUM (RSA AUMs + Other non-RSA funds) has grown at a 22% CAGR between 2007 and 2021 (a 15-year period) to N13.42tn in 2021 (US\$30.86bn, CAGR of 11%) on the back of rising number of RSA holders, new inflow of funds (contributions less withdrawals) into the funds and net investment gains, according to analysts at Chapel Hill Denham.

It is important to note that a tough and unpredictable macroeconomic environment and high unemployment rate are also responsible for low penetration.

Over 50 percent of a population of 200 million live on less than \$1.98 a day while inflation has squeezed consumer wallets.

Nigeria's unemployment rate rose from 27.1 per cent in the second quarter of 2020 to 33.3 per cent in the fourth quarter of 2020, latest figures from the National Bureau of Statistics (NBS).

bonds and mutual funds.

New York - which ranked first - is home to 345,600 millionaires, including 737 millionaires with a net worth of \$100 million or more, and 59 billionaires, according to the report based on June 30 data.

Tokyo ranked second, with 304,900 millionaire residents, and 12 billionaires. London, San Francisco and Singapore complete the opening five.

In addition to New York and San Francisco (3rd place), four other cities in the United States - Los Angeles (6th), Chicago (7th), Houston (8th) and Dallas (18th) entered the 20 richest cities based on the population of millionaires living in them. Houston made the biggest progress, jumping four spots from last year.

Other richest cities in the world according to the number of millionaires living in them are Beijing (9), Shanghai (10) and Hong Kong (12); in Europe - Zurich (15), and Geneva (19); and in Australia - Sydney (11) and Melbourne (17).

Fourteen of the 20 richest cities are in countries with a "golden visa" or "golden passport" program, which grants the wealthy resident or citizen rights in exchange for a significant investment, according to the report.

"The right to live, work and invest in international wealth centers such as New York, London, Singapore, Sydney and Toronto can be secured through investment," the report states.

Henley & Partners says it has has seen unprecedented enquiries



regarding alternative residence and/ or additional citizenship over the past few years from investors and wealthy families across the globe, including an increasing number of African nationals, and interest is constantly rising.

In the six months to the end of June 2022, it had already received 63% of the enquiries received in the entire 2021 year from affluent citizens of African countries.

South Africa and Nigeria are in the top 10 countries globally in terms of both enquiries and applications in 2022, and other African countries generating high levels of enquiries and applications are Algeria, Egypt, Ghana, Kenya, Morocco, and Uganda.

The top five programs that African nationals are enquiring about in 2022 are the Portugal Golden Residence Permit Program, the St. Kitts and Nevis Citizenship by Investment Program, the Canada Start-Up Visa Program, the Antigua and Barbuda Citizenship by Investment Program, and the UK Innovator Program. European destinations such as Malta, Montenegro, Spain, and Greece are also popular to secure either residence rights or citizenship through investment.

Supreme Court declares Ifeanyi Odii PDP Governorship candidate in Ebonyi

The Supreme Court has announced Ifeanyi Odii as the Governorship Candidate of the People's Democratic Party (PDP) in Ebonyi

Mr Odii will now fly the party's flag in the 2023 gubernatorial election.

The Apex Court further struck out the judgement of the Court of Appeal in Abuja, which had declared Senator Obinna Ogba, as the Governorship Candi-

In the lead judgement read by Justice Lawal Garba,



the five-man panel headed by Justice Amina Augie noted that senator Ogba did not have the right of Appeal because he was not part of the suit when the matter

came up at the trial court in Abakaliki, where Ogba's candidature was upturned.

Ifeanyi Odii, was elected the party's governorship 'candidate' during a canceled primary held between May 28th and 29th, 2022.

At a rescheduled primaries held on June 4th and 5th, 2022, Senator Ogba was declared winner, and Odii approached a Federal High Court sitting in Abakaliki which upturned Ogba's candidature, necessitating Ogba to approach the Court of Appeal.

The Appellate court there after ruled in his favor, however, the judgment annuls the Ogba's candidature and makes Ifeanyi Odii, the authentic candidate of the PDP for the Ebonyi state governorship polls.

Traders, market leaders clash in Anambra


Same-faith ticket: I'm also worried as a Christian, says Akeredolu



Among the four suspects detained in total in the probe, one was taken into custody on Tuesday and three on Wednesday, a judicial source added.

Mathias Pogba has earlier denied any involvement in extortion reported by his World Cup-winning footballer brother Paul.

Mathias's denial in a statement issued by his lawyer, Richard Arbib, comes after he published a bizarre video online on August 27 — in four languages (French, Italian, English and Spanish) promising "great revelations" about the Juventus star.

'Taking into account how the affair has evolved and the huge media attention surrounding it, Mathias Pogba strongly insists he knows nothing about any extortion attempt against his brother, Paul Pogba," read the statement.

Hamraoui: Aminata Diallo re-arrested by French police over attack on PSG teammate

Former Paris Saint-Germain player Aminata Diallo has been arrested and again taken into police custody in connection with an attack on one of her teammates, French media reported Friday.

It was the second time Diallo was arrested as part of an investigation into the attack last year on Kheira Hamraoui. Diallo was taken into custody in November and released without charges.

Quoting the Versailles prosecutor's office, the Journal Du Dimanche reported that Diallo was arrested on Friday morning and is suspected of having set up the attack on her teammate.

Diallo's questioning by police came after four men were arrested earlier this week in connection

with the attack.

Hamraoui was attacked following an evening out with Diallo and other teammates. Hamraoui was hit several times with a metal bar and needed stitches to her hands and legs.

Diallo has been without a club since her contract with PSG expired at the end of last season.

Earlier this year, Hamraoui bravely relived

the 'traumatic attack' after a team meal after revealing she feared for her life when two masked men beat her legs with iron bars.

'I experienced an attack of unbelievable violence,' she told French newspaper L'Equipe.

'Two hooded strangers took me out of the car I was traveling in to hit me on the legs with iron bars. That night, I really thought I was going to stay there... I was screaming in pain. I tried to protect myself as much as possible. I have a very painful memory.'

Diallo, 27, has played for PSG for six years, while fellow France international Hamraoui, 32, joined from Barcelona in July 2021.

The Spanish Football

Federation (RFEF) has strongly denied claims that its president Luis Rubiales used RFEF money to host orgies.

Spanish newspaper El Mundo reported that Rubiales is accused of holding private parties in a chalet in the Granada region to which "eight to ten young girls" were invited.

These parties were allegedly expensed as a work event, with the closest members of Rubiales' team present, and it is claimed that the RFEF president's former chief of staff Juan Rubiales, who is Luis Rubiales' uncle but was fired from his RFEF role in 2020, made the claims to the Prosecutor's Office last April.

El Mundo's report contains further accusations from Juan Rubiales made to Spain's anti-corruption department, such as Luis Rubiales allegedly telling him that he needed to "find a way of getting money out of the Federation" and using his influence to hire private



investigators to track the head of the Spanish Players' Association, David Aganzo.

On Thursday, however, the RFEF released a statement defending Rubiales in which it "categorically" denied the accusations which it says were made by an ex-employee "motivated by spite."

The full intervention of Juan Rubiales that is reported today by the newspaper El Mundo is once again a new exercise in falsehoods and manipulation by a former federative employee motivated by spite, as well as by his demonstrated alliances and recognized by those who seek a constant deterioration of the image of the president of the RFEF,"

the statement ran.

"El Mundo focuses the story on a new maneuver by Juan Rubiales, who once again accuses RFEF employees of irregular and inappropriate behavior at a work meeting with other department directors at which he was present.

The former chief of staff refers to a coexistence of planning and organization of federative executives in the town of Salobrena (in Granada) in which the accommodation was entirely paid by each attendee, including Juan Rubiales. Neither the employees nor the RFEF incurred any irregularity."

The federation said that despite the seriousness of the claims, Juan Rubiales has not provided a "single piece of evidence either in the Prosecutor's Office or in court to support his accusations," adding that his moves were "one more step in the infamous campaign" that Luis Rubiales "has been suffering in recent months."

The sentence Mendy could face may range from five to 20 years in prison, although he could face a possible life sentence.

In May 2022, Mendy pleaded not guilty to the nine counts of sexual offences against him.

MTN Nigeria uses capital raise to generate returns for shareholders

MTN Nigeria has been efficiently using the new monies coming into its coffers to create greater returns on assets and ultimately boost profitability.

The company said it has obtained regulatory approval from the Securities and Exchange Commission (SEC) to issue a \$233.7 million (N100 billion) Series I bond.

The Series I bond is part of MTN Nigeria's new \$467.4 million (N200 billion) bond issuance programme.

And it is expected that this year's capital raise will generate returns for shareholders as the telecoms giant is taking advantage of the country's young population that prefer to carry out transactions us-



ing their mobile phones to increase date voice and

Debt is a cheaper source of financing, as compared to equity. Companies can benefit from their debt instruments by expensing the interest payments made on existing debt and thereby reducing the company's taxable income.

GTCO's mobile, internet banking transaction up 33.25% to N16.55trn

...lead peers in digital service

An increased adoption of Guaranty Trust Bank Holdings Company (GTCO) Plc's electronic banking platforms indicates the lender is getting more customers to bank online while at the same time paving the way for the younger generation to carry out the majority of their transactions at home.

For instance, the value of mobile and internet banking transactions at GTCO spiked by 33.25 percent to N16.55 trillion in June 2022 from N12.42 trillion as at June 2021, according to data gathered from the lender's website.

A breakdown of the figures shows total value from mobile banking was up 38.18 percent to N15.20 trillion in the period under review from N11 trillion the previous year. Value of internet banking increased by 4.90 percent to N1.35 trillion from N1.42 trillion the previous year.

Álso, the volume of mobile and internet banking transactions spiked by 49.41 percent to N229.44 million in June 2022 from N153.56 billion the previous year.

"It appears the coronavirus pandemic that elicited a lockdown underpinned people's predilection for electronic banking and online transactions," said Abiola Rasaq, former analysts at United Africa Bank for Africa.

The platform is the next growth of the industry and there is intense competition between banks and the telcos who have just been given mobile banking licenses," said Abiola.

Of course, the uptick in GTCO's digital banking performance validates a recent report by the Economist Research Unit (EIU)-the research and analysis division of The Economist- that the lender was leading the digital banking race in sub-Saharan Africa by getting more customers to bank online and reducing communication gap with customers

"The lender's digital services extend beyond banking to online payments for services such as applying for passports. In traditional banking, GTBank has held its ground," said the research house



He observed that the scholarship programme, which started in 2010, was designed to produce top level professionals with technical manpower, capacity and expertise to compete in the oil and gas industry and in other



UBA boost investors' returns after record profit

Pan African lender United Bank for Africa (UBA) Plc has boosted investors' confidence after a record prof growth as it remains impervious to geopolitical tensions, rising inflation, currency devaluation, and regulatory headwinds.

Of course, the lenders' halfyear results beat analysts' expectations and its solid capital position means it has the buffers to absorb macroeconomic shocks.

The tier-one banks latest financial statement as analysed by MoneyCentral shows there are improvements in key financial ratios, and a surge in electronic banking revenue indicates the bank is serving the needs of its customers across the country who are enjoying expeditious transaction processing.


Interest and non-interest income underpins revenue, profit

For the first six months through June 2022, UBA's gross earnings increased by 17.80 percent to N372.75 billion from N316.03 billion the previous year; the growth at the top line (revenue) was largely driven by strong growth in interest and non-interest income.

A breakdown of revenue shows interest income was up 15.59 percent to N257.36 billion in the period under review from N222.63 billion the previous

Net interest income followed the same growth trajectory as it spiked by 19.90 percent to N177.46 billion in June 2022 from 148.06 billion the previous

Net interest income (NII) is the difference between the interest income a bank earns from its



lending activities and the interest it pays to depositors.

Also, net interest margin (NIM) increased to 5.70 percent in the period under review from 5.20 percent the previous year. The 50basis points improvement in NIM is on the back of continuous asset pricing whilst holding down funding cost.

The stellar performance was in line with management's expectation, adding that the Bank's continued focus on its Customer 1st philosophy to pursue the mission of providing superior value to our stakeholders had increased low-cost customer deposits, and boosted the growth of its payment and transaction banking, according to Oliver Alawuba, group managing director and CEO of UBA.

The lender saw net income increase by 16.10 percent to N70.33 billion in June 2022 from N60.58 billion the previous year, thanks to an uptick in fees and commission income and noninterest revenue.

It is important to note that

operating profit followed the growth trajectory as it was up 20.10 percent to N255.98 billion in June 2022 from N213.15 billion as at June 2021.

UBA is committed to delivering value to shareholders as the return on average equity (ROAE) rose to 17.70 percent in the period under review from 16.40 percent the previous year.

It must be noted that rising interest rates is also responsible for an improvement in earnings as the central bank adopts a hawkish tone to tame stubbornly high inflation.

The Monetary Policy Committee of the Central Bank of Nigeria has increase the benchmark interest rate (monetary policy rate) from 13% to 14%.

Of course, the non-performing Loans (NPLs) further dropped to 3.30 percent, which is lower than the 5 percent regulatory threshold, and thanks to prudent underwriting standards, and proactive credit monitoring.

Total customer deposits were up 5.70 percent to N6.72 billion as at June 2022, the single digit growth means deposits are not lying fallow and liabilities are not piling in the balance sheet

And more interesting is that customer deposits continue to dominate the Bank's funding mix (82 percent), even as CASA grew by 3 percent in the first half as the lender deepen wallet share of corporates, commercial and retail customers.

United Bank for Africa has a price to earnings multiples of 2.07 times, which validates an attractive valuation as analysts continue to reaffirm a Buy ratings on the stock with upside potentials.

It pays shareholders an attractive yield for owning a share of its stock, as its dividend yield of 13.42 percent makes it the best dividend paying stock on the NGXASI index.

Reaffirming its commitment to shareholders and the investing public, the Board of Directors of the Bank declared an interim dividend of N0.20 per share for every ordinary share of N0.50 each held by its shareholders.

"The financial year 2022 showed initial signs of recovery of economies across the globe, despite continued COVID-induced supply-chain disruptions. However, geopolitical challenges including the Russia and Ukraine conflict, resulted in escalation of global commodity prices, particularly grains and crude oil, which have taken a toll on several economies. Notwithstanding these developments, our half-year numbers came out stronger than the prior year, with top and bottom-line reaching new record highs," Alawuba summed.

uid resources.

A calculation greater than 1 means a company has more cash on hand than current debts, while a calculation less than 1 means a company has more short-term debt than cash.

It is noteworthy that the combined total current liabilities in the books of firms stood at N5.50 trillion as at June 2021, which is 4.07 times cash and cash and cash equivalent.

However, cash and cash quivalents are not the only source of meeting obligations on current liabilities, rather inventories are also current assets, especially for fast moving consumer goods (FMCG) firms, who are able to quickly convert inventories into cash to meet current obligations.

"Yes, that may be true for some companies and some are smart to have lines of credit with banks as a measure to bridge

such liquidity gaps when they arise. However, some companies' position may reflect their cash flow management strategy of leveraging payables to fund their operations while maintaining a very low cash conversion cycle," Abiola Rasaq, former economist at United Bank for

"Hence, whilst on the surface high current liabilities against lower current assets may be a sign of liquidity crisis, it is important to learn the strategy of the company," Abiola.

Data gathered by MoneyCentral shows that non-financial corporate businesses held up to N2.7 trillion of long term liabilities in their balance sheet in the first half, as firms took advantage of the low yield environment between 2019 to 2021, but the high interest rates buoyed by central bank's hawkish tone means they might put a brake on borrowing since they are likely to pay more to service those debts.

While earnings in different sectors for listed firms are showing signs of coming through the pandemic, they are not out through the woods yet.

This is because bellwether firms have burned cash so as to ramp up the purchase of raw materials as they had anticipated continuous rise in price of the grains brought on by the war between Russia and Ukraine and unfavorable change in foreign exchange.

Analysts say the liquidity challenges is a major concern given how much debt has been raised and how much liabilities are in the balance-sheet, but they added that firms will meet obligations to short term suppliers in so far as they are able to produce and sell those products.
